Education:

The functioning of Middle School Takiya Sangreshi, has been left out on RET teachers and the Head Master for last about 15-years is deployed with Head Office of Education Department. His salary is reportedly drawn against the strength of said Middle School, which is against the spirit of Finance Department instructions and interests of public activity. As such needs to be discarded forthwith.

Further, the Principal of HSS Khimber may depute the Teachers/ Lecturers of his institution to the Middle Schools and Private Schools as visiting Teachers for the benefit of the students, without compromising the interests of his institution.

Health Department:

The Health Sub-Centre is housed in a rental building having in-accessible approach road. The 4-room proposed building under construction for years has been left in dilapidated condition by the R&B Department resulting loss to government exchequer and property. The building needs to be completed in double shift working pattern, so that the Sub-Centre is made functional from its own infrastructure.

Further, considering the population of the Panchayat Halga Khimber, the Sub-Centre require to be upgraded to Primary Health Centre, for which purpose construction of 2nd storey require to be taken up in existing proposed Hospital building.

Forest, Ecology &Env. Department:

Although, the Soil & Water Conservation Department has treated about 140 Ha of forest land in the foot-hills of Khimber Watershed decades back, but the task for an open area of about 900 hectares barren land requires attention, for which the Soil & Water Conservation Department has to frame a DPR for its treatment particularly storage of rain-water for moisture conservation to enhance land productivity, and aquifer the rain water to develop the Watershed area. The treated area once barren land has turned into lush green, which to some extent cater the need of fuel & fodder of the local population, invited wildlife like: the black bear and hangul. The tiger is also reportedly seen sometimes.

The Forest Department has not demarcated the forest area, as a result there is absolute apprehension of encroachment by vested interests in connivance with the Forest and/or Revenue Department employees. The attention is required to save the government property \$5

Revenue Department:

As reported, there are about 3600 kanals of State/ Proprietary/ Grazing land in Panchayat Halqa Khimber. The people complained non-issuance of fard-intikhabs due to ban of section-5. On ascertaining the position from revenue officials, the Naib Tehsildar of the area stated that the matter is sub-judice with the Revenue Court. During last year, some encroachment has been removed by the then SDM Srinagar on the instructions of Divn.Com Kashmir. There are apprehensions of such encroachment in future as well. The people having own proprietary land were reported are suffering as well due to the blanket ban by the Revenue Court.

Accordingly, the Revenue Court is required to list the case regularly for early disposal of the case to deliver justice at the earliest, so that the genuine right-holders are not affected due to procedural delay.

Animal /Sheep Husbandry:

The Department is reported to have acquired 176 kanals of land for proposed sheep rearing Project costing to Rs.40 crore approximately. The unit is to be shifted actually from Dachigam. The participants have demanded to provide employment to the local population as well.

For good number of animal population in the PH, the area requires an Animal husbandry unit with requisite staff. In case of any uneven eventuality, the population has to shift their cattle to Animal Husbandry Unit Chatterhama, which is far away.

PMGSY

The organisation has taken up some work last year at Takiya Sangreshi, after which there is unspent amount of Rs.79 lacs. The locals have demanded to take up the drainage work or metalling of roads of the Takiya Sangreshi.

Un-used buildings.

One Irrigation building at Boonital-Khimber and One unit of two Bath-rooms constructed by Soil & Water Conservation at Takiya Sangreshi are abandoned for one or the other reason. The Sarpanch of the PH has agreed to make functional the Bath-rooms at Takiya Sangreshi. As regards, the irrigation building, the RDD may take up the issue with Irrigation Department for its common use for by the staff of Irrigation Department, Revenue Department etc. This will minimise the burden on state exchequer for construction of separate buildings and their maintenance, and shall provide the nearest access to the people of the area to attend their tasks. For this purpose, it would be appropriate, if the buildings are transferred and maintained by the Panchayat.

Rural Dev. & PR Deptt.

For better coordination between line Departments, the Secretary Panchayat has been advised to create a WhatsApp group called "PH Khimber" and register line-departmental representatives having working area of Khimber Panchyat. This needs to be looked into by the RDD.

The line departments were advised to submit the GPDP programme under 14th FCA by Sunday to the Panchayat Administrator for further projection and implementation. The Panchayat Bank Accounts are also required to be updated by including Sarpanch as one of the account holder under rules/occupations.

J&K Bank

The J&K Bank has agreed to establish its branch/unit at Khimber, for which the bank has identified two sites/buildings on road side. However, at one site, a private school is accommodated. To deescalate the tension among the locals, it was left for J&K Bank to select one of them, which meets the requirement of the bank. As such, the Bank authorities shall take their own course to settle the issue and make the branch/unit operational at the earliest.



General instructions for the visiting officer

- i. The visiting officer shall assess the ground situation of allotted Panchayat vis-a-vis perception of local public, data provided by different Departments, inputs shared by the PRI/ prominent citizens and his own observations.
- ii. Any conclusions drawn shall include a holistic view point of the general public including stakeholders. Efforts shall be made to bring out general highlights of the area based on consensus.
- The visiting officer shall restrain himself/ herself from giving or offering any commitment on behalf of the government.
- The visiting officer shall adopt an unbiased attitude in reporting issues of public importance.
- v. The report of the visiting officer shall be submitted both physically and electronically in the pre-circulated format. The officer shall exercise all care and objectivity while filling up the relevant form.
- vi. A suggestive activity schedule has been prepared for the visiting officer. It shall be incumbent on the officer to ensure that all activities and elements mentioned in the schedule are carried out/ covered fully.
- vii. The officer shall participate in the Gram Sabha and also ask the Gram Panchayat to constitute Social Audit Committee in case the same has not been constituted earlier.
- viii. He/She shall also hold interactions with prominent citizens, frontline government functionaries, NGOs/ social organization, respectable's of the area and the general public.
