

GENERAL ASSESSMENT OF THE VISITING OFFICER:

I. Main economic activities/ source of livelihood in the GP (Max. 05):

1. Cultivation of apple and walnuts.
2. Supply of cow milk to Main Town Bandipora.
3. Sheep rearing for mutton supply & silk worm rearing for cocoon production.
4. Cultivation of vegetables, oilseeds & vegetables.
5. Micro-entrepreneurship, wage labouring, salaried.

II. Major potential areas which can be used to improve economic conditions in the GP (Max. 05):

1. Tapping water of Gund Sai Nallah & Dehgam Nallah for irrigation to boost agriculture & horticulture.
2. Introduction of hybrid or HDV or exotic varieties in horticulture sector.
3. Mulberry plantation along banks of canals/sivers would boost Sericulture & cocoon production.
4. Introduction of organic farming, apiculture and Vermi Composting activities.
5. Establishment of vocational training centres for knitting, sewing & tailoring, mobile repairing, crewel embroidery etc.

III. Major problems confronting the people in the GP (Max. 05):

1. Non-accessibility of adequate portable water.
2. Non-availability of health infrastructure.
3. Inadequate infrastructure facility of upgraded Govt. H. Secondary School Quil.
4. Presence of inadequate and infeasible state land.
5. Non-availability of playground & recreational parks & street lighting facilities.

IV Urgent public requirements in order of priority (Max. 07):

Establishment of a PHC with Ambulance facility.

2. Upgradation/Construction of link road connecting Qorlat Kamker Mahalla to Bpr-Sopore road via Kema.

3. Establishment of a JK Micro-collection Centre with ATM facility & a Common Service Centre (CSC).

4. Macadamization/Metalling of internal roads/lanes along with drainage system.

5. Central localisation of Tehsil Hq. Moosa at some plain area having good road connectivity.

6. Exploitation of Spring water by laying pipes & augmentation of Borewell with mechanical support to cover households without portable water.

7. Need of Fire-Service facility.

V Any major complaint brought to notice:

Despite notified Qorl wayback as a Model village, the infrastructure in respect of health, drinking water, roads, electricity, education etc are lagging far behind as should be in a Model village, complained by locals. Besides, lying of Padwan Khannar & NT office building non-functional despite notified Qorl as Nayabat.

VI Overall assessment of visit (Public Services): Please mention best practices, if any, observed

Positive and satisfactory feed back from locals regarding the service provided by ISM Dispensary and Education department in particular. However, other departments are also doing good for the public but still there are challenges regarding non-availability of adequate resources.

VII Overall assessment of visit (Panchayat Functioning):

Currently the gram Panchayat is functioning without Sur-Panch and Panchs, resulting non-holding of gram Sabha's regularly and non-execution of all departmental plans on ground. Need of the hour is to elect Panchayat body - Panchs & Sur-Panchs so that gram Sabha is put into task to finalise the gram Panchayat Development Plan.
