2-	Villagers are not aware about different Schemes launched by different department from time to time.
3-	Lack of communication facility.
4-	Non-availability of public transport. So pregnant ladies face lot of hardships during their delivery.
II	Major/ urgent public demand(s) that was/were reflected earlier but have not been addressed so far:
1-	Upgradation of middle school Gundkamal to H.School as the population belongs to ST they have to cover 6 km to reach H.S. and this is the main cause of drop out particularly for girls.
2-	As there is no public transport and is immediate need of health sub centre with Ambulance.
3-	Connect the road from main road to Karamnag;
III	Overall assessment of visit and suggestions: (The visiting officer to ensure that the overall assessment is recorded in detail along with concrete suggestions.)
	The whole Panchayat lies near to within the vicinity of forest. There is almost non-availability of agriculture and horticulture land. So apiculture, dairy farming units, poultry farm and sheep farm units should be installed in the village to boost the economy of people. Middle School Gundkamal should be upgraded earliest as the students have to travel 6 km to reach H.School through forest and possess threat to wild life. Main reason of dropout particularly girls
