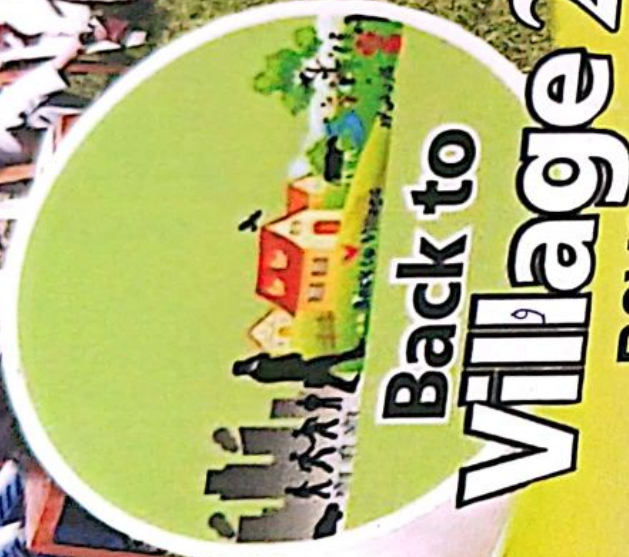

L) GENERAL ASSESSMENT OF THE VISITING OFFICER:

I	Urgent public requirements in order of priority (Max. 07):
1.	construction of passenger shed with ^{Toilet} Brickwork 02 nos. at Bus stand new bridge Peerniyon, (on National Highway)
2.	Improvement of light irrigation scheme by making the 2nd line of pipe already laid functional + improvement of irrigation channels of IJara, Pandhayat.
3.	Upgradation + Macadamisation of roads, a) From LJHP to Hujam Mohalla. d) Hrs. sec to chashni Mohalla. b) Main road to Dar Mohalla. e) LJHP to Rafter Mohalla. c) Main road to Shamsawari.
4.	Upgradation of PHE scheme Shamsawari, Dia, of pipes. needs to be increased + upgradation of filtration plant.
5.	Upgradation of infrastructure of electricity by providing wires for 5 kms, poles 150 Nos + transformers 05 Nos for Shamsawari, Dar Mohalla, chashni Mohalla + Mukhdoom Mohalla.
6.	Providing of J&K Bank Branch with ATM at IJARA + Const. of building for Public Library at IJara.
7.	Levelling of ground of Hrs. Sec. school, fencing, separate Toilet block for Boys + Girls + Renovation of old buildings (02 Nos)
II	Any major complaint brought to notice of the Visiting Officer:
1)	Demand for construction of new road from LJHP main road to Barhar.
2)	Renovation of old building of Govt ISM Dispensary at IJara with fencing.
3)	Const of R-wall / P Bund. at Shamsawari IJara. near the House of Mushtaq Hussain s/o. + Ashraf Hussain.
4)	Const. of road from IJara to Pehlipora main road + Upgradation of road from Panzal mulla to Badikar.
5)	Placement of Medical staff especially Gynaecologist B2V2/PD&MD/2019 at PHC IJara.

- 6) Golden card facility under Ayushman man Bharat. Scheme needs to be increased.

III	Overall perception of functioning of the government:	The inhabitants of the area are not satisfied with the results of Back to Village I, However expect good results after Back to Village II. They are satisfied with the performance of the Govt. Departments but needs implementation of their problems on ground.

Govt. employees of various Departments provided due cooperation. Such programmes should be conducted in future too, However implementation of the problems raised by the inhabitants should be implemented on ground for strategy farming to such programmes.
