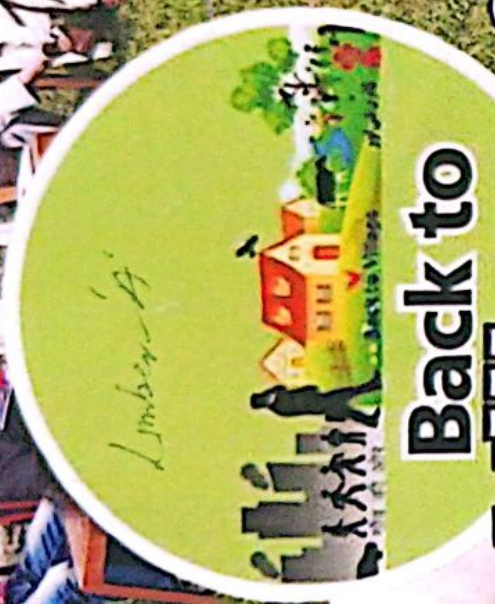


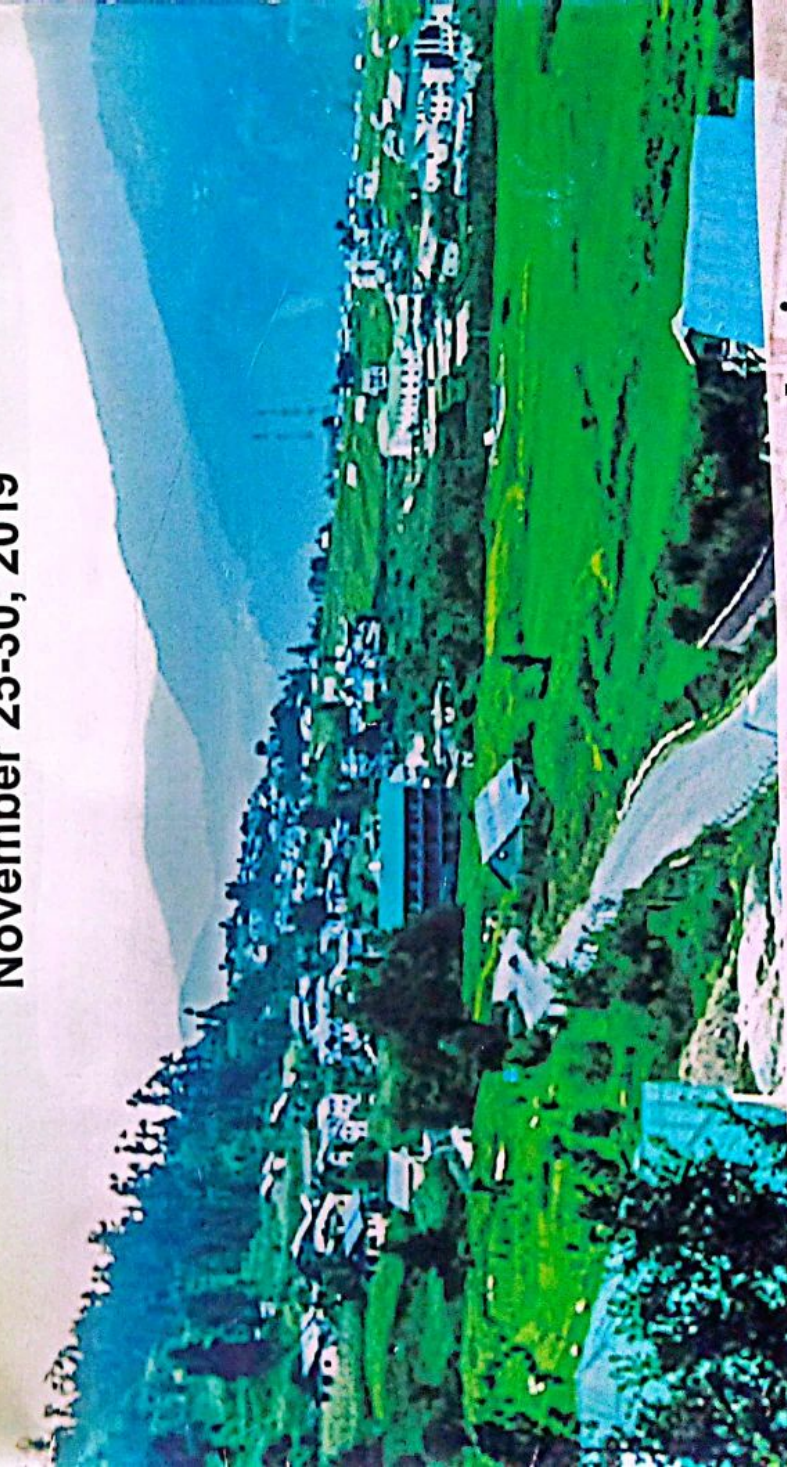

1) GENERAL ASSESSMENT OF THE VISITING OFFICER:

 2. Fish ponds/unity be established.
 3. Burning Network problem, Network towers be constructed at an earliest.
 4. Skill development training to youths.
 5. Lift Water supply scheme/irrigation from Nallah to Shahkote village & pipes.
 6. Social welfare scheme pending for a long.
 7. Dilapidated PHE pipes, Electric network, poles, wire, new PHE schemes.
- II Any major complaint brought to notice of the Visiting Officer:
- Network problem, Road Condition under process Bad, Electric wires/poles in dilapidated condition, School awareness lacking.

III	Overall perception of functioning of the government:	Almost all departments functioning, but due to paucity of funds most of the benefits are deprived to people.
