



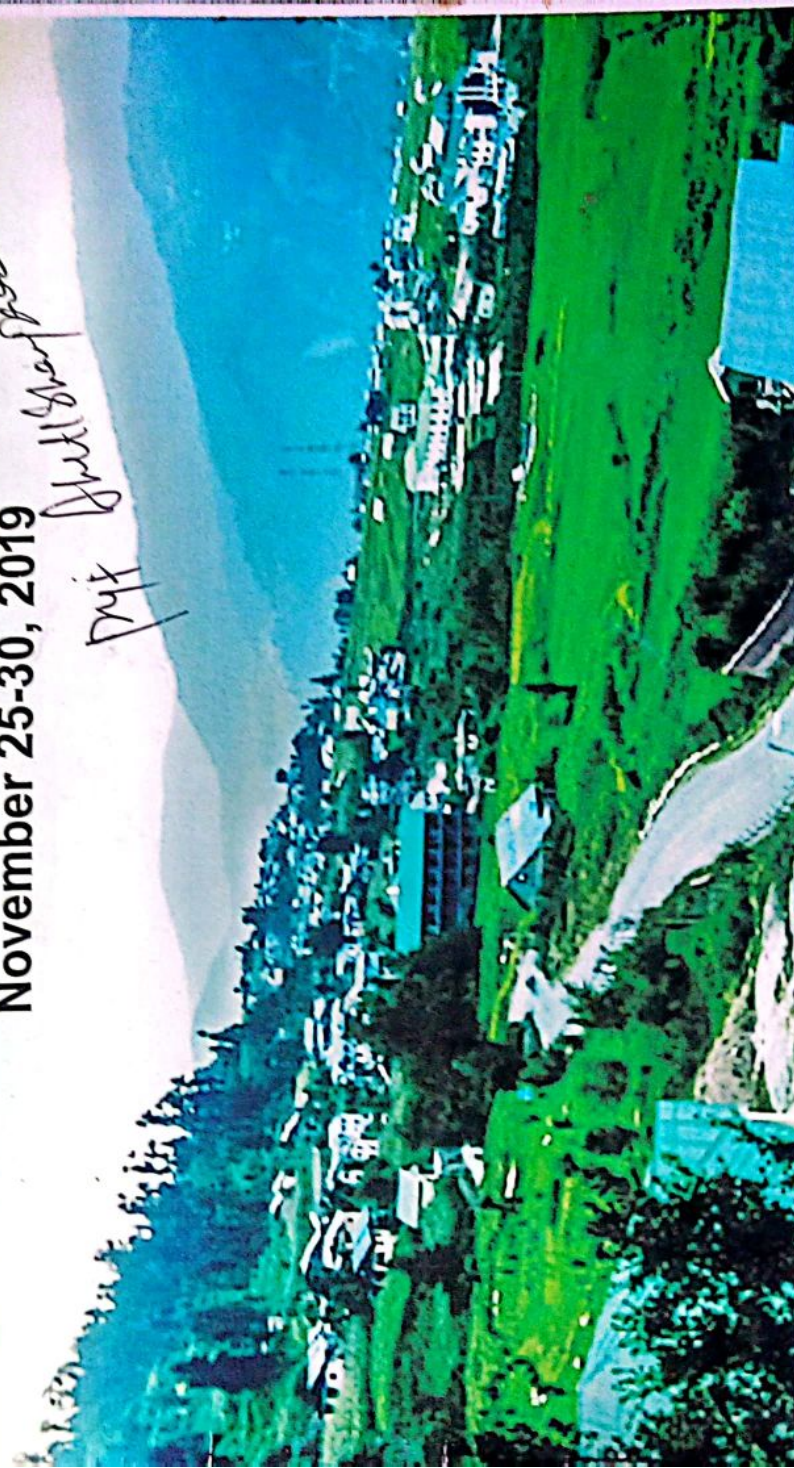

	Sanction of 3) three Nos. of Transfarmers of 4. Buzuthalla one, Khan Mohalla one and one for Washimani Mohalla along with DC Nos. of Electric poles and wire.
	5. Sanction of ICDS Centres for Khan Mohalla one and one for Abassi Mohalla in Azadpora.
	Ground for playing in Middle School Azadpora 6. Land available land for solution of accommodation problem construction of a three roomed building.
	The Primary School Building of Buzuthalla is 7. Seeping, collapsed, disbracted, there fore usage needs to be reconstructed.

	The major Complaint was about the insufficient and inadequate drinking water and irrigation facilities in the panchayat Halqa.
