5. Wires required for new installed transformers in W. No. 1 near house of Ramashree Singh.
6. Attention of PHE Deptt towards irregular supply of water and people also demand for new connection.
7. Construction of lane down and protection wall near Khu-Talab about 200m long over arch in W. No. 3.

II Any major complaint brought to notice of the Visiting Officer:

1. Major complaint of locals of this ~~pro~~panchayat is about CARD. As officials of this particular department are not available during ^{any} Gram Sabha and no response given by this department earlier - keeps on much denied about the working of this department.
2. Employees of ~~MGN~~ MGNREGA should be regularised as they do most of the work of R.B.
