- Health sector - NO Doctor is available in the G.P and additional staff be posted in the G.P
- School - Insufficient staff in all schools, additional staff need to be posted on regular basis
- Anganwadi centres need to be provided with furniture + utensils/other items which can help in improvement of their work
- R&B - Cancellation of govt. land to Mehjar Road as it can cause damage to village
- PRI - Honorarium given to Panchayat/Sarpanch is very meagre and needs to be increased
- PHE - PHE authorities + officials need to be equipped with basic requirements as they complain about it
- Bank - Bank authorities are not cooperating in sanctioning of K-CC Corrs

III Overall perception of functioning of the government:

People are largely satisfied with the govt but want more funds allotted / works sanctioned through the Back to village programme as it can prove more beneficial than other programmes.

IV Overall assessment of visit and suggestions:
