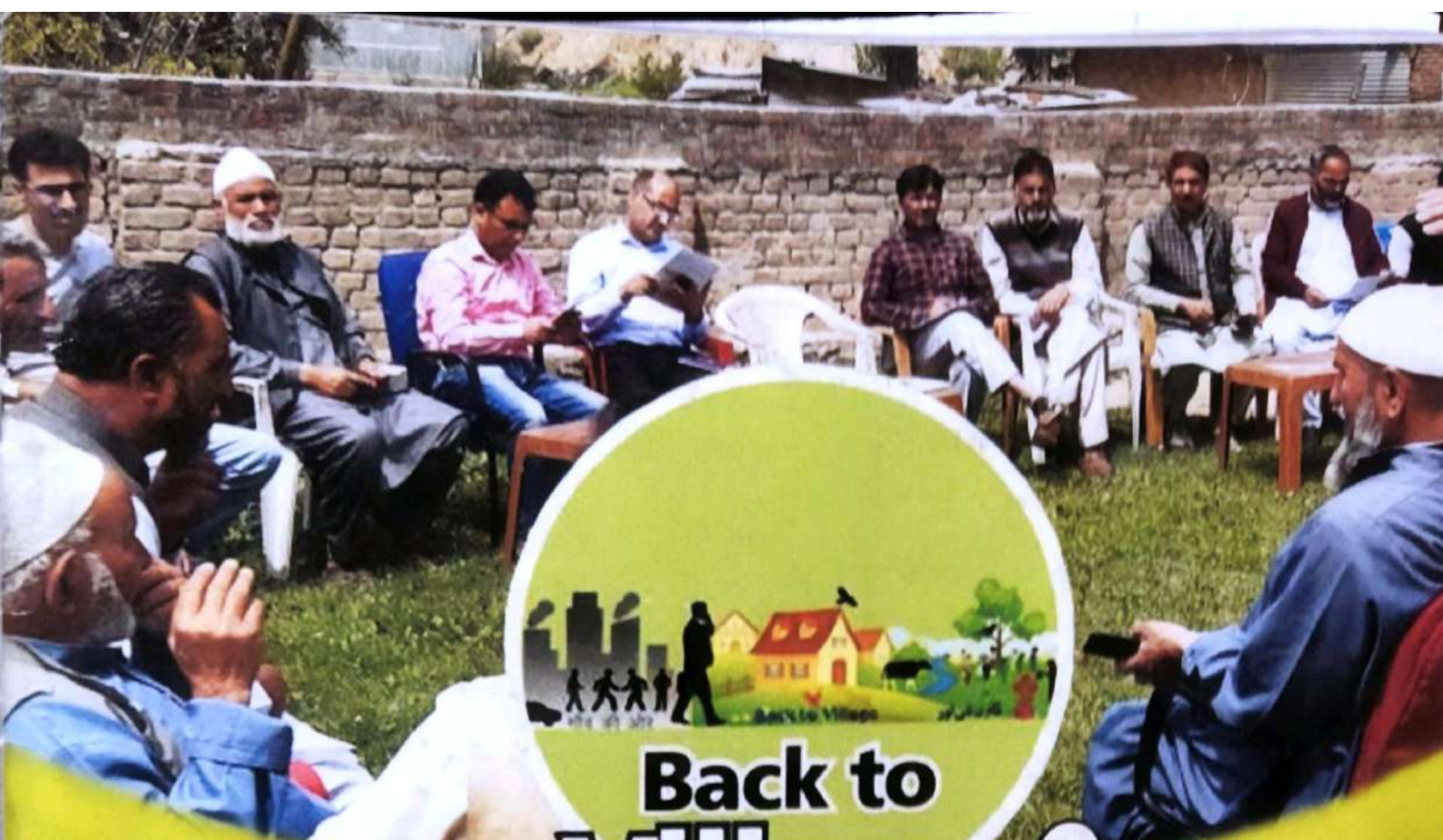


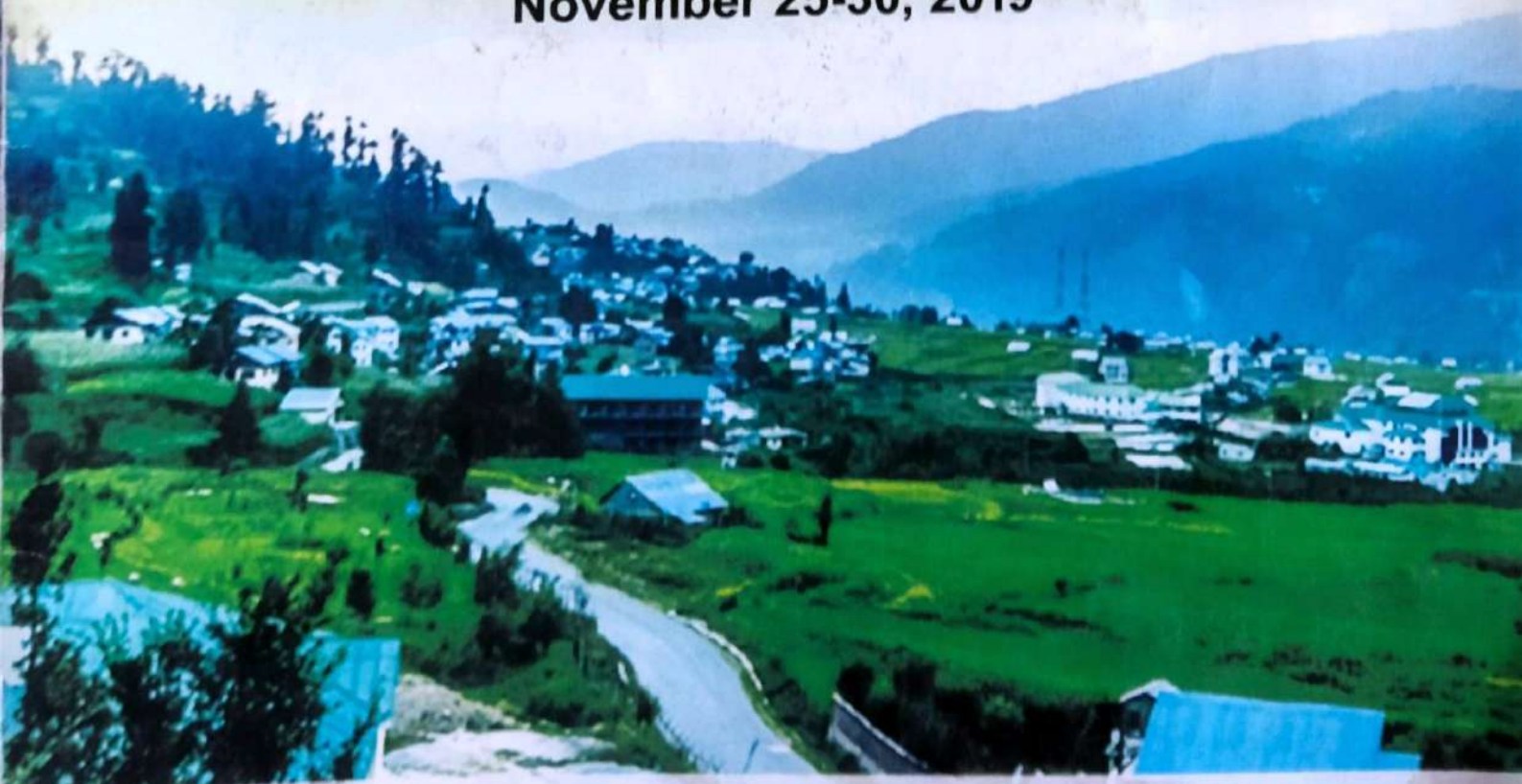

I Urgent public requirements in order of priority (Max. 07):

1. Registration for food store along with Building.
2. Upgradation of Primary Sub-centre to Primary Health Centre along with proper Infrastructure
3. Compensation to fruit growers along with free supply of plants, fertilizers and pesticides.
4. Awareness Camps need to be organised by different govt. departments.
5. Establishment of different Handicraft Centers and assistance units for the empowerment of women.
6. Installation of Electric poles and transmission lines.
7. Marriage Assistance scheme should be revised on the pattern of 2013 Survey.

8. Upgradation of existing Infrastructure in CHSS Authora / copy of demands enclosed.

II Any major complaint brought to notice of the Visiting Officer:

Transmission Lines need to be restored / changed on Urgent basis.

III Overall perception of functioning of the government:

General Public Complaints about the shortage of funds to different departments under different schemes.

IV Overall assessment of visit and suggestions:

Overall assessment of visit remained satisfactory but the response of general public was not as good as was in BZVI due to non completion of works which were taken by BZVI officers. Works started by BZVI need to be completed.
