

L) GENERAL ASSESSMENT OF THE VISITING OFFICER:

I	Urgent public requirements in order of priority (Max. 07):
	1) Black Topping of Link road from Kousa Pani To Kudgawn village. & Black Topping of all link roads to all wards of Panchayat Kuthiyala.
	2) Primary health centre (PHC) at village Kudgawn & upgrading of Sub. health centre of village Kuthiyala. & fulfilling of shortage of staff in Kuthiyala.
	3) Drinking water supply to Dhansal area via Nilhote. & drinking water supply from Kousa Pani To Kudgawn via Kuthiyala.
	4) village <u>Shilothu</u> is most neglected area of the Panchayat. Electric wires fitted on trees instead of electric poles. Single water connection for entire village. Not even a P.S in village.
	5) Education Department to look into issue of shortage of staff in H.S Jathi. upgrade Hanging H.S Jathi into a full fledged H. school. Also ensure Examination centre in the school for 10th class.
	6) Public of Panchayat demands that if a K.V school is constructed anywhere in the Panchayat. People of the area would not migrate to Sammu/Judhampur for quality education of their children.
	7) Major Agriculture land exists in Jathi but for the lack of irrigation supply, production badly suffers. Already existing irrigation canal needs to be restored properly to benefit large number of farmers.
II	Any major complaint brought to notice of the Visiting Officer: 8) Irrigation canal from Jathi To Dhansal is needed.
1)	Recently upgraded Sub. health centre lacks shortage of staff. Post. of Doctor is vacant. Medical assistant also attached ^{with} PHC Assar. Public is very annoyed with the medical Department.
2)	People from each village of Panchayat have complaint against mal-functioning of irrigation & PHE Department.

Already taken up work in B₂V₁ has not been started till date, although everyone is hopeful
