	the only Irrigation canal which irrigates whole of G.P from Sonmulla to Sirappur is in critical condition and needs urgent renovation/improvement.
	3 Hamlets of G.P i.e Tulwari, Bhail Mohalla and Yathan are without portable water so urgently need to provide them with water supply.
	4 Hamlets of G.P i.e Granie Mohalla, Lane Mohalla, Beig Mohalla & Ashkanpora without electric transportation.
	Construction of bund along roadside from the shop of Mohd Sultan Chapar to Residence of At. Rehman Sheikh via the House of At. Mohuddin Khan.
	6. Immediate and urgent Compensation to farmers whose agriculture/horticulture produce & orchards were damaged due to untimely snowfall.
	7. K.C.C loans should be waived off immediately.
II	Any major complaint brought to notice of the Visiting Officer:
	the only first aid centre in Gram Panchayat is defunct. Staff members are absent from duties most of the time. Medicines available at the said centre are not sufficient. The said centre is functioning from Awkarf building which is dilapidated.

Public perception towards functioning of government is not encouraging. Due to the delay and languishing of work people are dissatisfied with employees. The attitude of government employees especially health dept ~~are~~ further alienating the masses.
