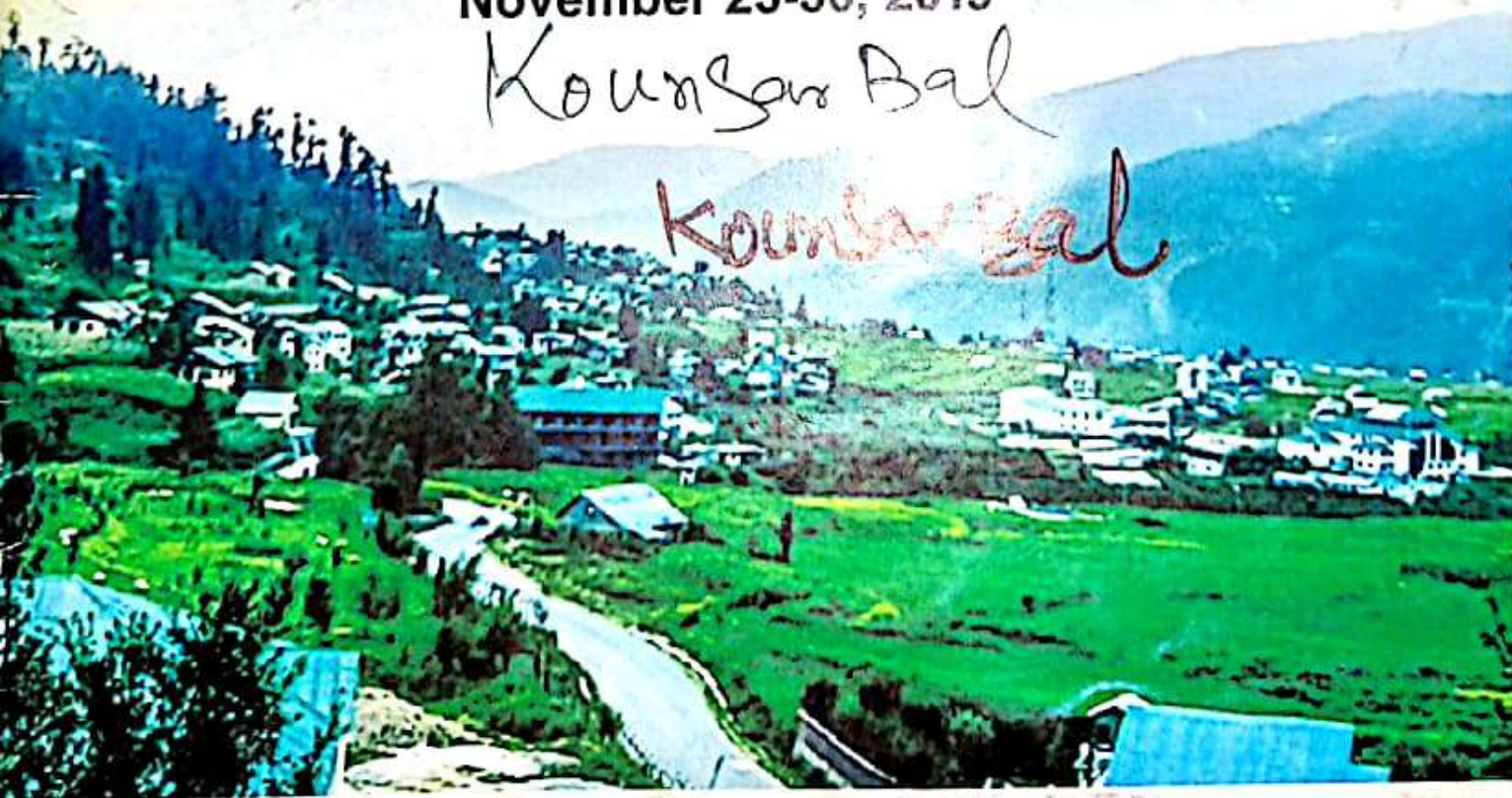

Deficiency of electric wiring & poles in whole halga.
