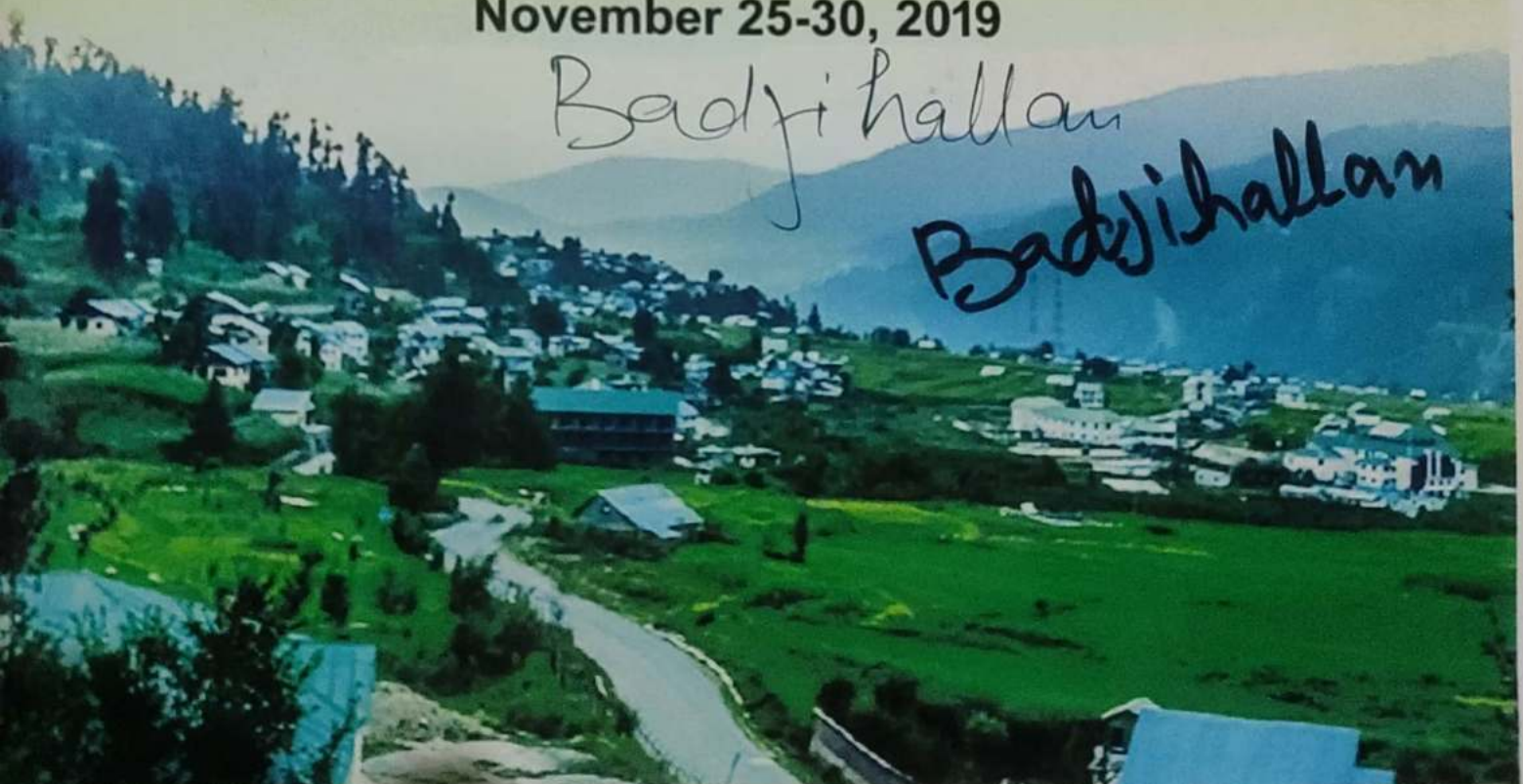

Being a hilly & hilly area, the Panchayat remains cutoff during winters from District & Tehsil Headquarters because of heavy snowfall. As such people face lot of difficulties during winters particularly of Public transport & food supplies. Therefore, snow-cutter should be stationed at D.K. Marg and stocking of food essentials should be ensured before winters.
