L) GENERAL ASSESSMENT OF THE VISITING OFFICER:

I	Urgent public requirements in order of priority (Max. 07):
1.	Road to Anchakri, Koharpura, Lahridhak, Kara & Kalihanad to Dal Draman (Tourist spot)
2.	Electric Poles, wire for HT & LT & transformers for the Panchayat.
3.	Water supply scheme from Silhal to Kalihanad, Anchakri, Koharpura & filter Plant at Kalihanad
4.	Anganwadi Centers at Pandit Basti, Sageta, Koharpura & Anchakri & Handloom Center at these places.
5.	Need staff at UPS Kalihanad & PMC & other school where teachers are overburden.
6.	Shift this Panchayat from Teh Doda to Bharat Basti as Bharat Basti is hardly 4 Km from Kalihanad.
7.	Need Patwar Halqa at Kalihanad
8.	At Kalihanad ^{Sageta} night ^{frequency} intention wire tower are going over the village which is also one concern
II	Any major complaint brought to notice of the Visiting Officer: as well as ^{dangerous for} villagers
	→ Roads are in bad condition → Insufficient staff in schools & PMC → Need water supply → Shift the Panchayat from Doda to Bharat Basti → Shift over head towers of electricity wire over the villages of this Panchayat

III	Overall perception of functioning of the government:
	Some dept. like R.D., edu, Health are performing well. However people are not full satisfied with departments like PHE, PDD, PWD/R & B. This pvt. lack basic facilities like adequate electricity, connectivity & proper irrigation facilities.
IV	Overall assessment of visit and suggestions:
	(the visiting officer to ensure that the overall assessment is recorded in detail along with concrete suggestions.)

The general public is not satisfied about the action taken on B2V1 programme. There is clear need of awareness programmes regarding various public welfare schemes of the govt. More stress need to be laid on basic needs like water, road, irrigation facilities & electricity in this Panchayat. People are unemployed in this pvt & MGNREGSA should be more strength to provide at least 100 days work to every skilled as well as unskilled labour.
