As a visiting officer of Panchayat Hala Boh, I found many genuine problems facing common people related to, Health, Education, Drinking water, Flood and electricity. The main threat to the village is Boshi vallah flood. Flood has inundated the whole village in 2014. People are yearning for basic health facilities, majority of them are suffering from water borne diseases due to drinking of contaminated water. Children are walking 3-4 km daily on foot for secondary education.

Suggestions:-

- ① construction of lining wall of Boshi vallah
- ② Establishment of primary Health centre.
- ③ Provision of pure drinking water facility to the people.
- ④ upgradation of M/S to H/S.
