Although the GP is hilly and also due to the inclement weather, we reached out the people and listen the grievances of the people. Most of the people complaint about the persisting roads and the very much dept (PMGSY) has totally neglected this area and doing the projects in a sluggish way.

Therefore, I strongly suggest to speed up and widening of the roads should be given due consideration.
