Overall perception of functioning of the government:

Generally people believe govt's approach is deceptive - nobody cares about the problems of people. Problems identified during B2V1 were not redressed.

Overall assessment of visit and suggestions:

(the visiting officer to ensure that the overall assessment is recorded in detail along with concrete suggestions.)

Due to prevailing uncertainty we could not visit the village on the specified date of 29, 30 Nov. 2019. Instead we stayed at CD block Kulgam. People were not excited like they were during B2V1.

I think Govt. should have ^{first} redressed the previous problems identified during B2V1, rather than jumping to B2V2.
