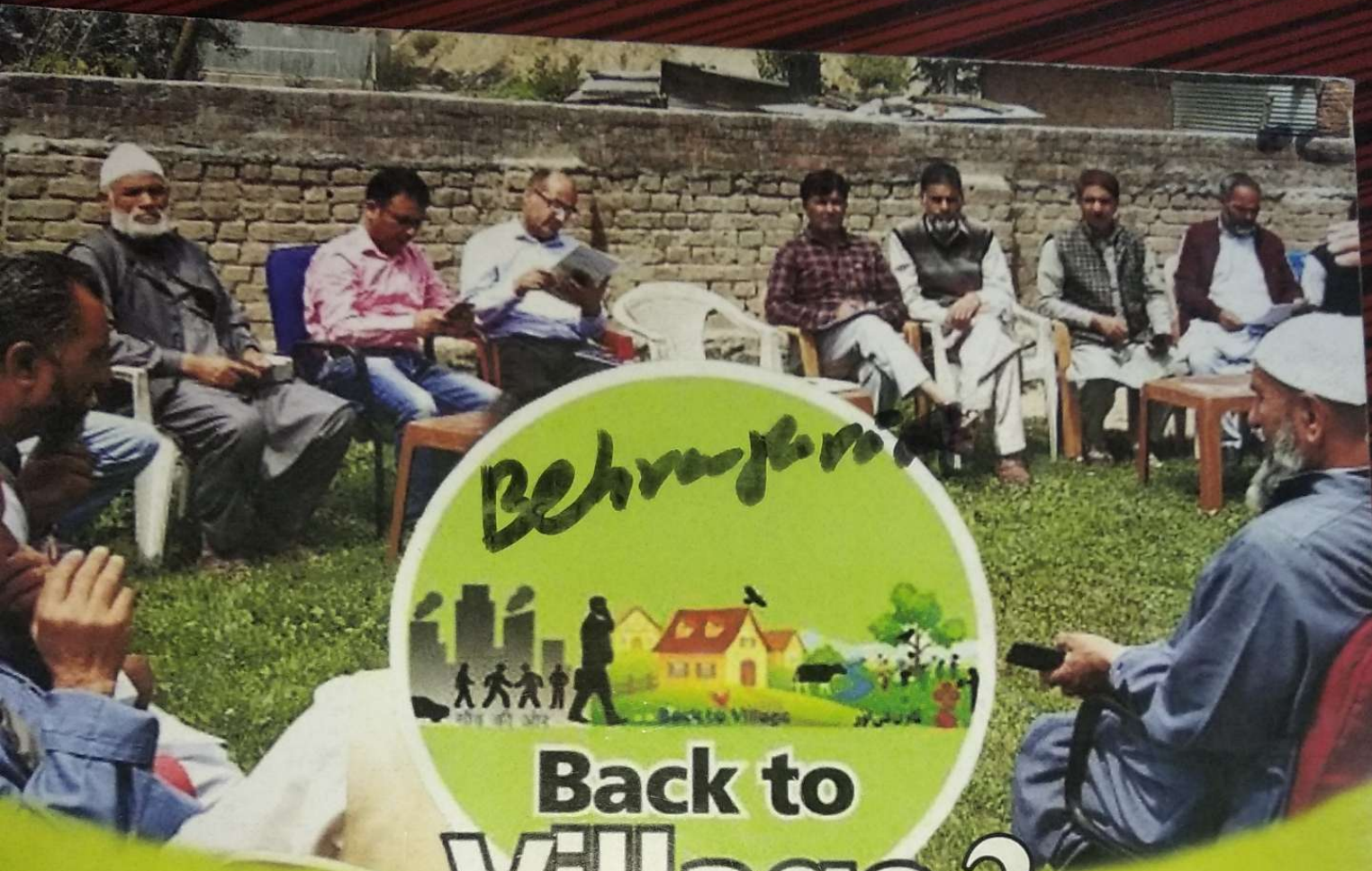

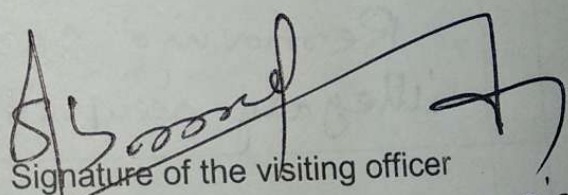

Cold Storage facility urgently needed as govt, land is available already 5. Desilting of irrigation channels by JCB and disposal of garbage at proper place and requirement of gnase system. 6. Construction of Road from Ziyarat Shreef (Dedamaji) via land of Ashuj Hussain Rather to Rogund. 7. Removing occupation of govt land, illegally occupied by locals & need for fire and emergency
