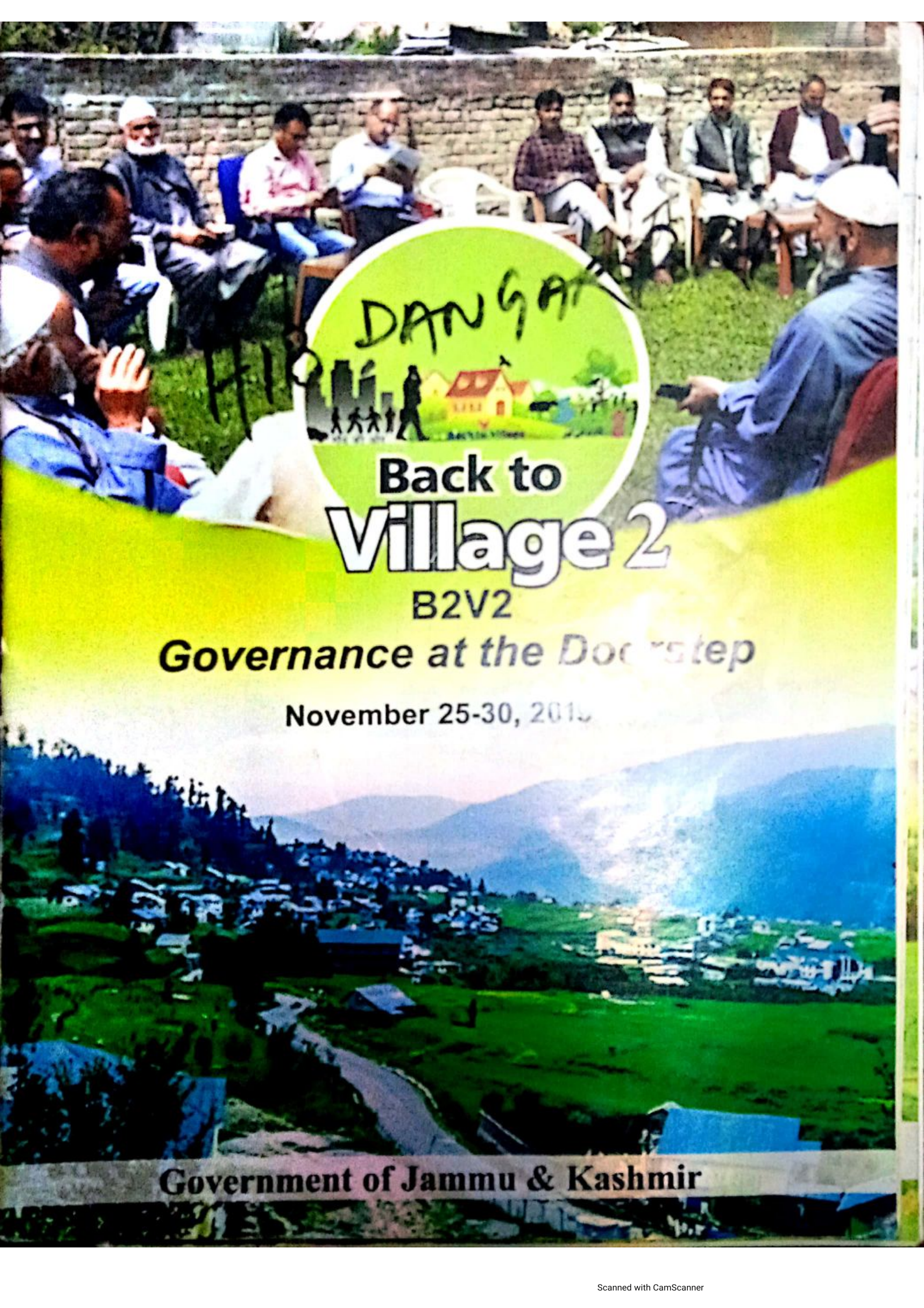

It was impossible to listen or to visit different places in the taluka if Mr. Anand Shah (V.L.N) and Mr. Anand Shah (G.S.) both from KOP & P.R. have not given me full support and a quotation from start to end. Last but not least, I thank to all the village level persons in taluka and beyond after submitting my 1st & 2nd future course of action.
