



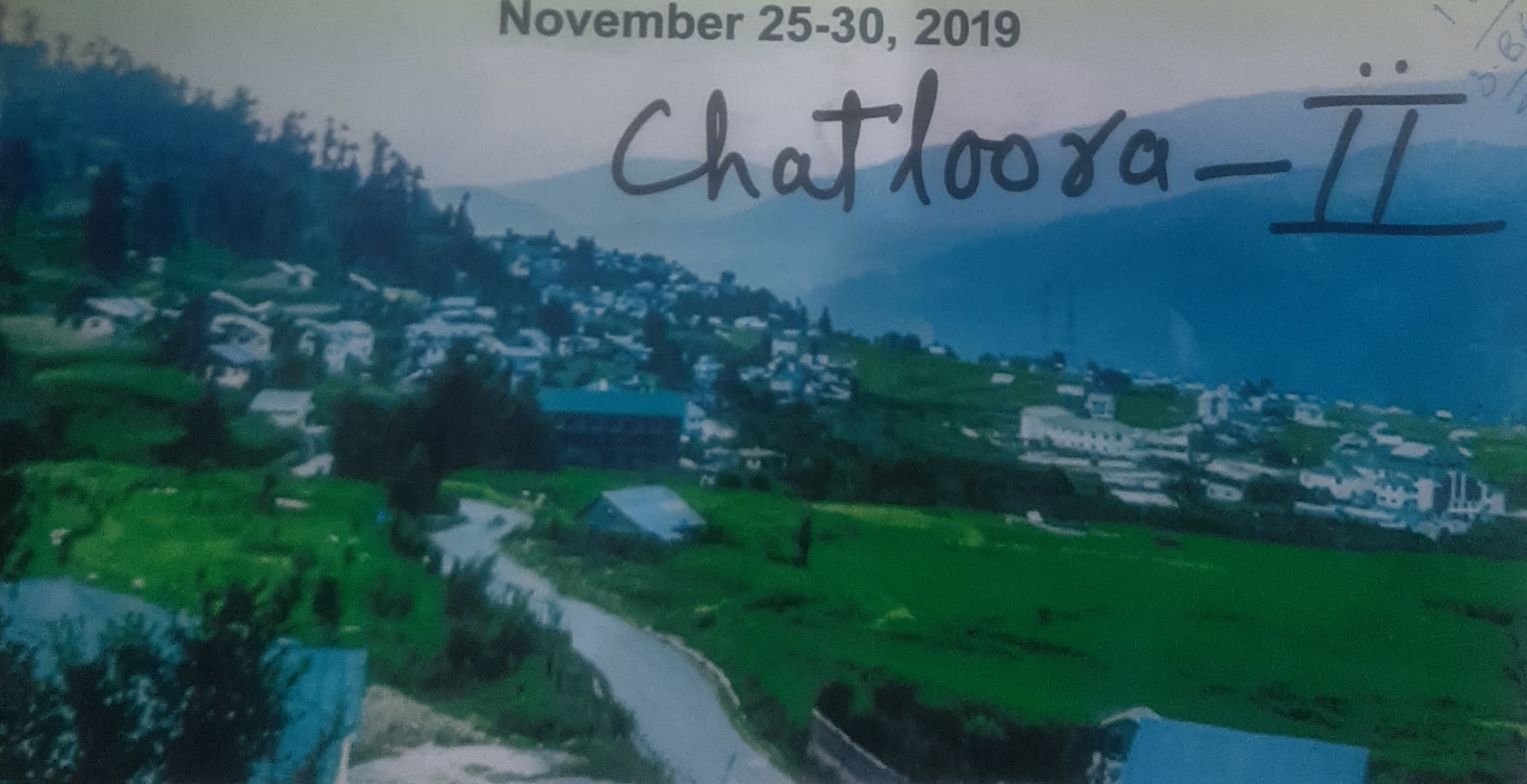

Urgent public requirements in order of priority (Max. 07):

1. Installation of Two no. Transformers along with electric poles and distribution lines at New colony - B & NH/ Ab. Adad Bhat & MET School.

2. Sanction of new water supply scheme at Chatlova, as this was one of the main demand put forth by the public.

3. Upgradation of M/s to H/s on modern lines

4. Road widening from NHW to Chatlova inc. macadamization of link roads.

5. Sheep extension centre at Chatlova

6. Upg. of Sub. centre to Primary Health centre.

7. Dig wells (50 nos) at various water deficit places at Chatlova.

II Any major complaint brought to notice of the Visiting Officer:

Food Security is one of the main issue confronting local poor households. Most of the people deserve BPL Ration tickets. So, it is proposed that at least 50 ration tickets of BPL / AAY category may be sanctioned.

People are contented with the working of govt machinery, but delay in fund release & execution of work has hampered the development scenario of the halqa.
