	Also mentioned in the B2V1 phase kit, that a Bridge constructed last three years back to give approach to the village Hamsuchak at zero level, but no approach constructed till now.

III Overall perception of functioning of the government:

Whether the Govt. Institutions are running/ functioning in the Panchayat, they are running without the legal staff strength which at time results in poor implementation of schemes.

IV Overall assessment of visit and suggestions:

(the visiting officer to ensure that the overall assessment is recorded in detail along with concrete suggestions.)

The Public PRI's are not much aware about the schemes of the different Departments, so more & more camps should be organised at Pyl. level to create more awareness. Also took help of some NGOs etc. more ^{information} given on Soil Health status to farmers.
- Need of the hour is to subsidised employment to improve work culture habit among general public & avoiding unnecessary free-byes.
