	The major complaints of the villagers is about P.H.E and P.D.D. Both these departments are not providing necessary services to the people. P.H.E has failed to provide piped drinking water to the people. Due to negligence of P.D.D. employees people face hardships as power supply often remains off.

III Overall perception of functioning of the government:	The Panchayat is not satisfied with the report provided to them by various departments and people are neither satisfied with the Panchayat body nor with its work. Besides, people of the village are of the view that there is mis-governance at all levels.
IV Overall assessment of visit and suggestions: (The visiting officer to ensure that the overall assessment is recorded in detail along with concrete suggestions.)	During visit, I found that below four services are being provided to the village. People are dissatisfied with the Govt. at all levels. The Panchayat made during last to village I was not fulfilled. My sincere suggestion is that at least 50% of public requirements mentioned in this letter need to be fulfilled before taking another survey.
