1. Upgradation of two old transformers from 250kv to 500kv at main Chowk near Mohallah, Gori Mohallah, Chittisandya. Requirement of three new transformers of 250kv at wahi Mohallah, Khatra Mohallah & 25kv at new Colony Ward No. 03.
2. Demand of Genet for Existing tube well inside Jani's masjid & replacement of old rusted <sup>water</sup> pipes.
3. Demand of pipes for the Borewell that will connect with the reservoir.
4. Construction of new road from the house of Habibullah Lane up to house of Shahr Ahmad Lane near that will Boggy Nagar.
5. Construction of bridge connection Aragam to Chittisandya near Army Camp at Nallah Aragam.
6. Construction of road from Graveyard (Shehad Mangayyar) up to house of Mushdag Ahmad Chopan.
7. Upgradation of Existing <sup>middle</sup> school to high school & J&K Bank Branch needed!
