	<ol style="list-style-type: none"> <li>Road condition very poor. Roads in the PH Nadihal C aren't fit for pedestrian traffic in wet weather. Road leading to the Halka from Sgo-BlaNH is very damaged.</li> <li>Government school building and infrastructure needs to be upgraded.</li> </ol>	
	<ol style="list-style-type: none"> <li>Delay in completion of Chak Gujri National Lift Irrigation Scheme, which is a languishing project.</li> </ol>	
	<ol style="list-style-type: none"> <li>Demand of PHC and upgradation of sub-centre.</li> <li>Ambulance facility must be available.</li> </ol>	
	<ol style="list-style-type: none"> <li>Electric poles and water supply pipes need to be replaced at many locations.</li> </ol>	
	<ol style="list-style-type: none"> <li>Agriculture equipment and agriculture machinery at subsidised rates from department. Hybrid seeds and high produce orchard plants be provided in the PH Nadihal C.</li> </ol>	
	<ol style="list-style-type: none"> <li>Road from Nadihal to chak gujri through orchards must be developed for better transportation to and from orchards.</li> </ol>	
II	Any major complaint brought to notice of the Visiting Officer:	
	<ol style="list-style-type: none"> <li>Roads leading to Nadihal from NH Sgo-Bla and S.N.H. Bla-Kupwara must be repaired immediately.</li> <li>Inner link roads in the area are in worst condition. Roads not fit for pedestrian traffic in wet weather.</li> <li>Chak Gujri National Lift Irrigation scheme to be completed as early as possible.</li> <li>People are educationally and economically backward. People of the area of PH Nadihal C are demanding for backward status for a long time.</li> </ol>	

III	Overall perception of functioning of the government:
	<p>As per the villagers, the corruption in the government offices affects the good governance.</p> <p>People are of the perception that their demands and requirements haven't been fulfilled by the governments.</p> <p>People say the roads are in worst condition on which Govt. hasn't taken any steps.</p>
IV	Overall assessment of visit and suggestions:
	<p>(the visiting officer to ensure that the overall assessment is recorded in detail along with concrete suggestions.)</p> <ol style="list-style-type: none"> <li>1. The roads leading to Nathal-C are in worst condition. The inner link roads in the area are also in bad shape. These are not fit for pedestrian traffic also. This must be resolved.</li> <li>2. People are dependent on Agriculture and Horticulture. Scientific practices should be implemented in these sectors. Agricultural equipments should be provided.</li> <li>3. People are in need of a medical facility with a doctor posted there. The current medical sub-centre should be upgraded. People have to walk 10 plus kilometers to visit a Doctor. Ambulance facility should be available.</li> <li>4. Social welfare schemes must be implemented in PH Nathal-C. People are educationally and economically backward. Sign boards for different Govt. schemes for economically backward people should be installed.</li> <li>5. Animal and Sheep Husbandry departments should conduct awareness campaigns in the area as the village is mostly agriculture dependent. Advertising Boards should be installed at particular places, so that the villagers take advantage of different schemes under the said departments.</li> </ol>
