People say the roads are in worst condition on which Govt. hasn't taken any steps.

IV Overall assessment of visit and suggestions:

1. The roads leading to Nadihal-C are in worst condition. The inner link roads in the area are also in bad shape. They aren't fit for pedestrian traffic also. This must be resolved.
2. People are dependent on Agriculture and horticulture. Scientific practices should be implemented in these sectors. Agricultural equipments should be provided.
3. People are in need of a medical facility with a doctor posted there. The current medical sub-centre should be upgraded. People have to visit 14 plus kilometers to visit a doctor. Ambulance facility should be available.
4. Social welfare schemes must be implemented in PH Nadihal-C. People are educationally and economically backward. Sign boards for different Govt. schemes for economically backward people should be installed.
5. Animal and Sheep Husbandary departments should conduct awareness campaigns in the area as the village is mostly agriculture dependent. Advertising Boards should be installed at particular places so that the villagers take advantage of different schemes under the said departments.
