L) GENERAL ASSESSMENT OF THE VISITING OFFICER:

I	Urgent public requirements in order of priority (Max. 07):
	1. Construction of road alongside Retikul from main road to Patushai.
	2. Construction of road from main trunk to Retikul via Sofimehalla.
	3. Seribal nag lift irrigation, filtration plant cum over head tank (OHT).
	4. Construction of School building for Girls middle School and 2nd story of GHS.
	5. Establishment of cricket playground.
	6. Establishment of Animal husbandry building cum sheep centre.
	7. Establishment of sub centre with ambulance.
II	Any major complaint brought to notice of the Visiting Officer:
	- Nehar Zainger and most of the water pipes are not properly maintained & conserved. - People use to put cow dung and kitchen waste directly into the Nehar Zaingis. - Even there were complaints that some inhabitants put their toilet outlets directly on the water pipes. - Non availability of electric poles and transmission wiring.

→ Abdul Hai Gurgani has blocked the drain, due to which water logging takes place at the above mentioned person's house.

→ Land demarcation particularly at Dr. Rafiq's house.
 → Main road to Retikul (Gh. Rasool wants, Payoon etc. main) create problem in construction, moreover people demand building of drain at the same site.

III Overall perception of functioning of the government:

General public is satisfied with the overall functioning / performance of the Govt. They are very much enthusiastic/interested in adapting new schemes launched by the different departments. Even though their grievances made in B2V, had not been fully addressed yet, still they are hopeful that the same is going to be addressed very soon.
