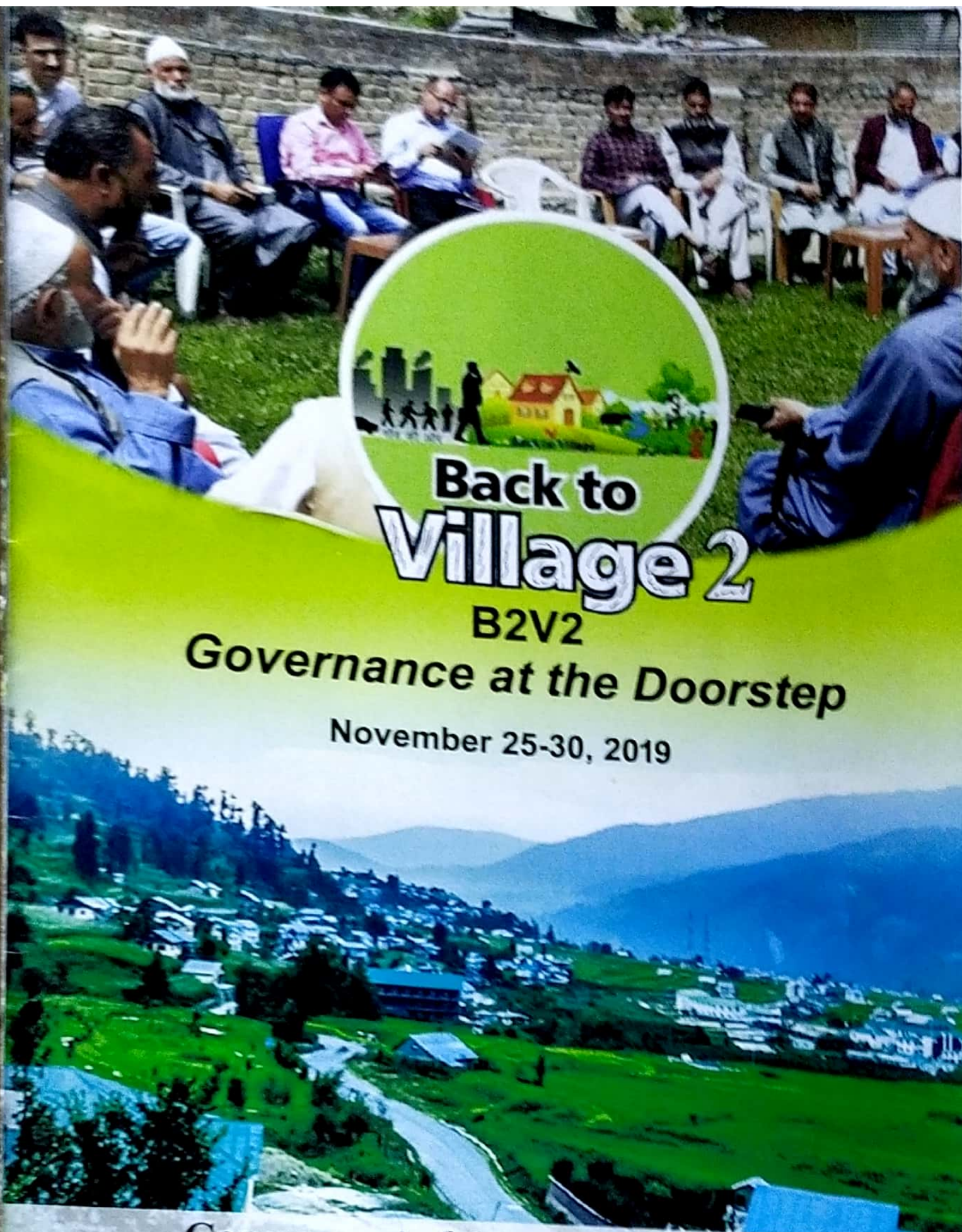

The people are very happy by the name of government. However, there is a communication gap between the various departments and the peoples which creates a lot of hindrance in execution of developmental works and amenities/facilities being provided by the different departments.

IV Overall assessment of visit and suggestions.
