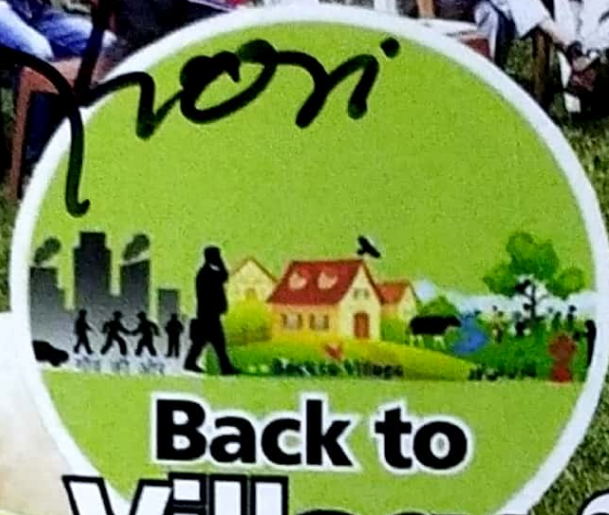

I	Urgent public requirements in order of priority (Max. 07):
1.	Public Health Centre (PHC) & Ambulance facility.
2.	Public transport - → Construction of Niabat & CSC.
3.	Bank Branch & ATM facility.
4.	Sheep & Animal husbandry centre & Store of high yielding seeds / fruits (Horticulture)
5.	→ Upgradation of High School to Higher secondary & PS Dhar to MS Dhar. → Renovation of PS-Koka Basti.
6.	Anganwari Centre at " <u>Dramni</u> " Dhar & Law.
7.	→ Removal of SFC store as that is defunct or make that properly functional. → Issuing BPL ration card to deserving.
II	Any major complaint brought to notice of the Visiting Officer:
	1. Non-availability of food supply. 2. Attachments of School Staff (Teachers) 3. Land compensation pending from many years. 4. Insufficient medical Aid 5. Various departments not working in the Panchayat eg. horticulture, Irrigation, fisheries, Revenue (Patwari) 6. The school (PS-Khori) is present in Dhar & PS-Dhar is present in Khori region, leads to confusion among teachers & public. 7. Education standard is very poor.

III Overall perception of functioning of the government:

- People are not satisfy with the over all functioning of the govt, expectations are ~~the~~ more/high.
- Frontline workers (Daily wagers, HR) of PDD, PHE are working whole heartedly but don't get enough support/resource.
- Manpower of various departments (horticulture, Sheep & Animal husbandry etc) is inadequate/sufficient.

IV Overall assessment of visit and suggestions:

(the visiting officer to ensure that the overall assessment is recorded in detail along with concrete suggestions.)

- Locals were very disappointed as not much progress was made, after B2V1, in any field.
Suggestion: All works started or taken up in B2V1 must be completed as early as possible & govt. officials should take concrete steps to come upto expectations of local people.
- As the panchayat is selected to focus on for encouraging women empowerment by reserving the sarpanch seat to women but unfortunately that is lacking.
Suggestion: The govt. departments (RDD especially) / official make sure to deal with selected sarpanch & not with her assistant.
- Quality is lacking in all fields. ~~It is~~ to quality rather than quantity.
