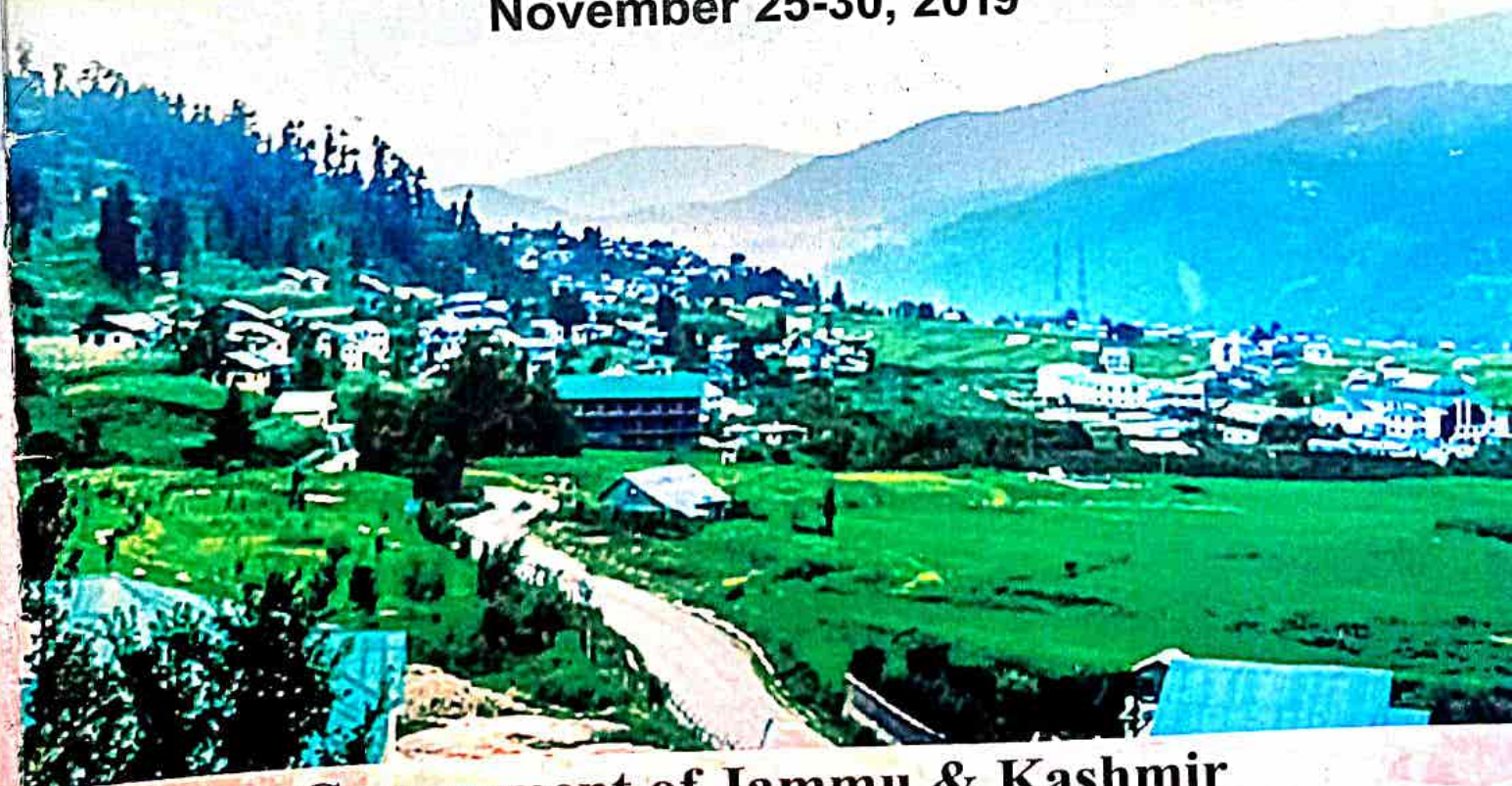

II	Any major complaint brought to notice of the Visiting Officer:
	There is no road connectivity in the Panchayat The Panchayat is under great threat of land sliding. Thula Bridges are required on Nallah Hill, Nallah banjar & Pillian and Jamadaran.

III	Overall perception of functioning of the government:
	Due to no road connectivity and tough terrain the functioning of government establishment is not satisfactory up to the mark due to far flung areas.
IV	Overall assessment of visit and suggestions: (the visiting officer to ensure that the overall assessment is recorded in detail along with concrete suggestions.)
	The Panchayat is far flung area from main city mandal and there is no road connectivity due to which the people of Panchayat suffer a lot. So, the most important work needed for the Panchayat chellu is Road Road Connectivity.
