5.	Construction & upgradation of Taleem Nagar road (4 kms), Inner link road chipam mohalla near Masjid Shaif, Construction of Hagen poshpora road.
6.	Dumping yard for household rubbish which pollutes the water bodies & creates a health hazard.
7.	Construction of Drain with stub from Masjid Shaif to middle school link road Sanction of four more Anganwadi centres.
