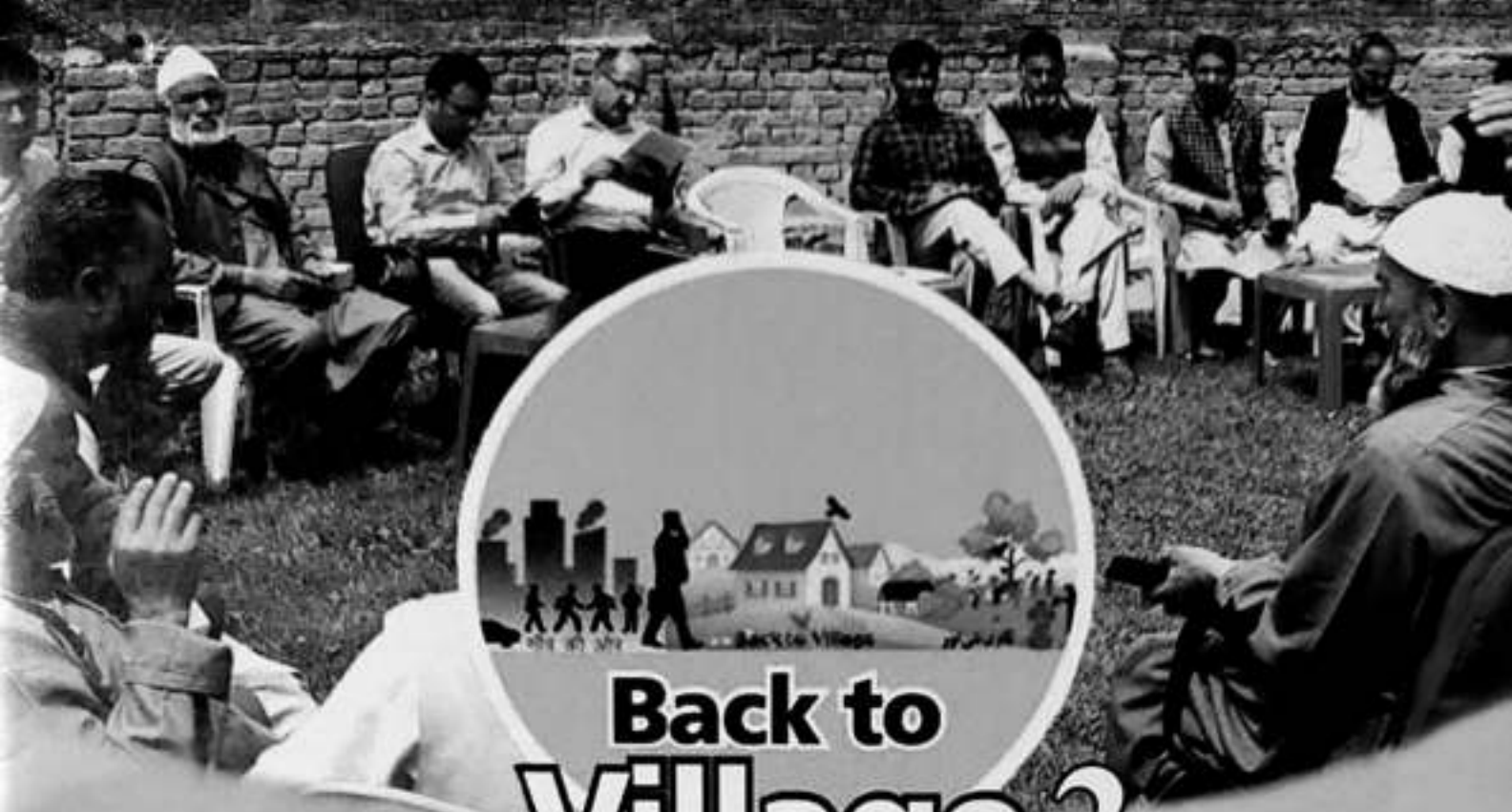

	Such Programmes energise the Panchayats by making the idea of Participatory planning reality and listening as well as redressing the grievances of public and providing basic facilities at doorsteps. These Programmes should be conducted regularly with some deviation to enable the officers to execute the approved work on ground.
