2.	Upgradation of PHE To Medical Block, fencing & land filling of outer yard may be provided
3.	Development of Lal-Khel to improve irrigation facilities.
4.	The link roads & inner lanes are in bad condition especially in Newbigh area of village & need to be repaired.
5.	Additional electric poles may be provided to people for L.T lines as some are being raised on trees at some places.
6.	Development of Lal-Khel for irrigation as the village falls on tail end and suffer due to shortage of water.
7.	Locals demand generator facility for Babbar Tujas Water Supply Scheme.
II	Any major complaint brought to notice of the Visiting Officer:
1.	Bad condition of Power supply
2.	Bad condition of inner roads
3.	Inadequate Drinking Water supply
4.	Overall drainage problem in almost through out the village.

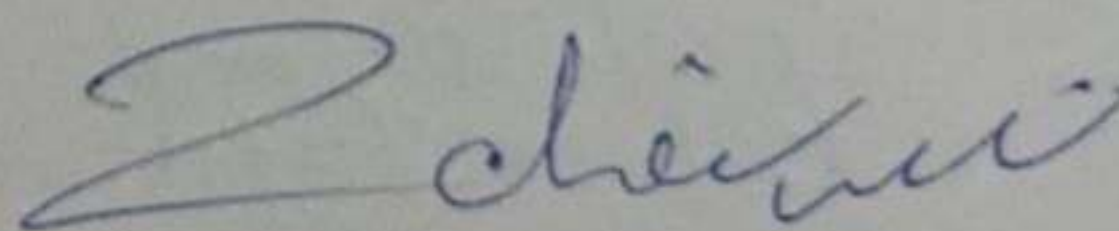
