Panchayat members are almost aware regarding various augmented ^{govt.} schemes and are making ^{people} aware about ~~the~~ same. Upto Sohal everything is functioning smoothly but rest of the villages of panchayat i.e. kabban and Ungai are suffering the most. They are lacking most of the facilities required for daily life. Major issue of the area is no connectivity of Road and communication.
