1	Road connectivity to all the wards of Panchayat kashabari
2	upgradation of roads & proper maintenance of roads
3	Upgradation of G.H.S kashabari to G.H.S.S kashabari
4	Electricity connection to all house hold of Panchayat kashabari
5	Drinking water facilities to all habitants of Panchayat kashabari
6	Boundary wall, drinking water facility, electricity connection and availability of Ambulance in N.T.P.H.C kashabari
III	Overall assessment of visit and suggestions: (The visiting officer to ensure that the overall assessment is recorded in detail along with concrete suggestions.)
