# I) GENERAL ASSESSMENT OF THE VISITING OFFICER:

II	Major/ urgent public demand(s) that was/were reflected earlier but have not been addressed so far: Till date no public demand of panchayat has been addressed. They have possessed a negative approach. People are not allowed to construct home because of revenue department. All concerned dept. need to be intimated. Regarding concern problem faced by the people of Bajnal Panchayat.
III	Overall assessment of visit and suggestions: (The visiting officer to ensure that the overall assessment is recorded in detail along with concrete suggestions.) The min. demands of water, electricity, domicile certificates, & major road connectivity issue need to be addressed as early as possible if BSVY need to be conducted. The locals are quite cooperative. IAY pending cases from 2016-17.
