The people in the P/H Wagon were totally disappointed in B2V2 as nothing concrete was done after B2V1 and B2V2. <u>Suggestions</u> ① The requirements given in order of priority must be done, at least a few of them if not all. ② The visiting officers must be given some authority to start or sanction a few/some works on spot so that people have faith on these officials.
