④ Making bundles in fencing wall of M/s Chakreshipra by forest department as well as private person named Ali Mohd. Jan. The fact of the matter is that a school building has been constructed on gaschari land measuring 1 kanal 17 marlas situated at Chakreshipra. From the records of Revenue records it is clear that land is gaschari & no forest land is involved in the construction of school. From the complaint pointed during this it transpires that one person namely Ali Mohd. Jan connivance with the forest dept is putting bundles in fencing walls. The staff posted at school also complained that they are being threatened by forest officials & the above mentioned persons. Accordingly Dist. administration is requested to kindly take immediate necessary measures to break the unholy nexus b/w the forest dept & above mentioned person.

⑤ Illegal occupation of govt. school building. One of the buildings of B. J. middle school Aythulla is illegally occupied by private person namely Mr. Jassid dar for the business but known to him. With the result the students of the area are suffering badly as the other building is not been put into use because of insufficient accommodation. During my previous visits the same complaint was also launched by the inhabitants but the authorities have failed till date to get the said building vacated from unauthorized occupation.
