I	Any major complaint brought to the notice of the Visiting Officer: A) Poor quality work being executed by PMSY in Road 4km Chabbri area onwards B) High billing of Electricity for all inspite of many using only light bulbs. No metering. C) Absence of Incharge High School Puneja since long. D) No monthly visits by RBSK team since long.
II	Major/ urgent public demand(s) that was/were reflected earlier but have not been addressed so far: A) Road Connectivity: ① Thalella to Puneja to Kotni Piam B) PHE Pipe line for ① Kotni Piam ② Asthan to Khat Moh. C) Upgradation of HS Puneja to HSS Puneja D) Upgradation of Health Sub Centre to PHC would cover four PHS: Thalella, Bhallara, Puneja & Jagota. E) Community Hall in W.No. 03 & W.No. 5. F) Cremation ground & shed construction in W.No. 03 & 02. G) Monthly medical camps should be organised.
III	Overall assessment of visit and suggestions: (The visiting officer to ensure that the overall assessment is recorded in detail along with concrete suggestions.) There is dire need of better Road Connectivity and PHC. The blacktopping of road from Suigowari to Puneja be considered on Priority. Water Scarcity Problem should be addressed.
