the projects which need immediate are as follows.

- ① providing of drinkable water to the residents Phalgunda-A
 - ② while the tap water facility is made available the people requested for implantation of pump to draw water from Khumnie for low-water availability.
 - ③ for with the purpose of dewatering during logging months, the gates such as at Khuge be restarted.
 - ④ Dredging of canal b/w dawayal to Khumnie
 - ⑤ widening of the canal.
- The whole GP is dependent on agriculture. The one requires immediate attention from regional & flood control, so that their agricultural produce is not left to the mercy of flood.
- In that regard the gates, which have been established since 40 years back be restarted for dewatering in agricultural land.
