Message

I am delighted to learn that the 3rd session of the much-acclaimed Back to Village-2 (B2V2) programme, a unique and ambitious mission of taking government to the doorstep of the people is being exposed here 3rd in Oct/ October 2020, across Jammu & Kashmir.

In June 2019, the Government of Jammu and Kashmir embarked on the Back to Village programme, which involved the visit of over 4000 District officers of J&K to every tehsil and spreading two days and a night drive. It was also an opportunity to support and strengthen the newly constituted Panchayats. The programme was a huge success. Visiting officials were welcomed and hosted by populace eager to share its wisdom and enrich with what they had perceived as an innovative administration. In fact such was the enthusiasm generated by the programme that the Hon'ble Prime Minister made a mention of it in the 'Man Ki Baat', calling it 'a harbinger of development, public participation and public awareness'.

Encouraged by the success of the programme, the government organized the Back to Village-2 (B2V2) in November 2019. This time the focus was on ensuring that funds and functions devolved to the Panchayats were used without any bottlenecks and that beneficiary oriented schemes actually reach the real person in the village. The Hon'ble Prime Minister again made mention of the programme in his Independence Day speech of 2020.

I believe the upcoming version of the Back to Village-3 (B2V3) programme will be an attempt at a consolidated and sustained developmental push in the region. The actual programme shall be preceded by a three weeks Jan Abhiyan (Janos Mahotsav) which shall focus on 3 concurrent and inter-connected goals: Jan Surma (Janos Surma) - Public grievances redressal, Adhikar Abhiyan (Adhikar Surma-Mahotsav) - Public Service Delivery and Usual Ghar Abhiyan (Desh Seva Mahotsav) - Delivery of Development on ground.

I am confident that this unique effort shall earn the respect of the people of Jammu and Kashmir and that it will be remembered for long as a unique and sincere effort of the government to reach the doorsteps of the people.
