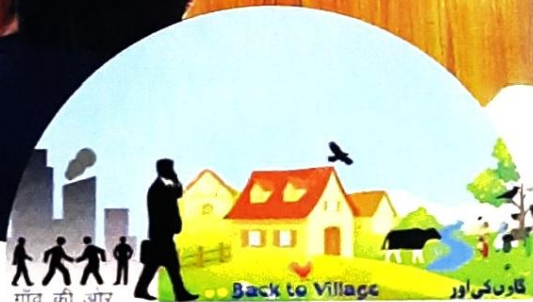

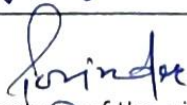

Basic needs like drinking water, road etc. require more focus. → Besides MGNREGA and other social assistance schemes, focus shall be made to remove illiteracy, unemployment for welfare and prosperity of Panchayat.
