Any major complaint brought to the notice of the Visiting Officer:

The concerned departments are not paying satisfactory attention to the problems of the Halga. It is only RDD who is doing some work in the Halga. The bathrooms constructed by some house holders have not been paid.

Major urgent public demand(s) that was/were reflected earlier but have not been addressed so far:

- ① Repairment of roads and minor links
- ② Providing safe drinking water (burning problem at Kishyara)
- ③ non-availability of CHC in Halga
- ④ Completion of left irrigation scheme from Dinguwacha to Walla Badsick
- ⑤ non availability of public transport
- ⑥ improvement to be made in L-T. networks

Overall assessment of visit and suggestions:

Out of three villages two are totally backward. Have been ignored by the R and B, PHE departments. The people are submissive. Out of nine wards only two ward members are elected. The remaining wards are vacant that hampers the functioning of the Panchayat.
