GENERAL INSTRUCTIONS

**OBSERVATIONS/DETAILED REPORT OF PANCHAYAT HALQA ~~XXXXXXXX~~
ANTNANG**

I along with frontline workers from other departments visited various sites and after brief interaction and discussion with the residents of Panchayat Halqa Zadoora Anantnag on very first day i.e 28.10.2022 and 29.10.2022. The team Visited and inspected various Govt Works executed and other sites to be taken up as per the demand of the Public. It was observed by the team of delegation from various departments and as requested by the locals that a Playground should be constructed on the available state land and wherever encroachment of such land is found the same may be removed. As influential people have illegally raised constructions along the river bank and have encroached Amrit Sarovars. Moreover, no Public/Private sector bank facility has ventured out to open the ATM with the village premises and it was demanded by the public that an ATM be installed on the available public place. It was also observed that the villagers are unaware about various schemes launched by the Govt from time to time. Various Departments like Sheep Husbandry, Animal Husbandry, Social Welfare, floriculture and rest other departments were introduced first time to the public by Visiting Officer. The villagers during the public meeting raised serious concerns and allegations against the revenue Department in terms of Ladli-Beti Scheme. However, My suggestion is that along with Panchayat and Auqaf/ Senior Citizens of the village may be taken into confidence for various Developmental schemes in order to bring transparency and grass root level change in implementation and dispensation of such schemes. It was also demanded by the public that a Panchayat Ghar should be constructed in order to look into the problems and basic requirement of the people of the village Zadoora. One Middle School located in the village Zadoora has dilapidated toilet blocks and there is urgent requirement of renovation and needs to be upgraded to High School so that students especially the girls are provided education at door steps. Several other demands were put forward by locals which has been enlisted in the Village Development Plan and Capex plan. Last but not least I may like to suggest that stringent measures may be adopted to stop the drug menace in the village by involving the community head like Preachers and Senior Citizens to conduct the social audit regarding the drugs and its ill effects so that it can be tackled in a better way. A team from Department may be deputed in order to counsel the youth regarding the negative effects of drugs and substance abuse.

The making of uniform for the school children should be through SHGS of the Panchayat. The problem is to sell their different items through District Level Administration. The Mid-day Meal is provided as per food chart. It should be necessary that the SSA must purchase their raw material from the locals/SHGS. If the Panchayat there is only one shop to purchase the uniform so, the lack of uniform is also the biggest problem among the Panchayat women's/Locals. The Umeed Organization should be there whenever the Sabha conducts. The basic need is to purchase/sell their products on bigger platform. The conclusion is that lack of platform to sell their products, demands under Janani Suraksha Yojana, demand to install CCTV Camera at Village Level.

Bal Sabha

Today on 20-4-22, Bal Sabha Meeting held at Panchayat Palli in ward No. 3.

The agenda of the meeting to conduct Bal Sabha to create awareness among the children of Panchayat Palli for good education, play games. Children suggested that for development good lanes, drain, road, hospital, schools, gym, gym centre, playground, library required. Mam also made the children aware for Swachh Bharat, Gram Sabha, planning of works, Bal Sabha, No Drugs, No Child Labour.

After the PM Visit the Yoga Classes to be held daily in Panchayat Ghar Palli.

4. Listing of Sacred Groves, Sacred Water Bodies, and potential Biodiversity Heritage Sites (from within forests with rich biodiversity which can be conserved and managed by the Village Panchayat).
5. Identification of Non Timber Forest Products (NTFP) found within the jurisdiction of BHC, which can be sustainably collected and utilized.
6. Conservation of traditional varieties/seeds of economically important plant/animals.
7. Need assessment for capacity building of Biodiversity Management Committees.

Subject: Conduct of meeting of Biodiversity Management Committee (BMC) during Fourth Phase of Back to Village Programme (B2V4).

The Government of J&K has constituted Biodiversity Management Committees (BMCs) in all the 4,290 Village Panchayats and 76 Urban Local Bodies (ULBs) as per the Biological Diversity Act, 2002 & Rules, 2004 for conservation and sustainable use of biodiversity. The BMCs are mandated to document the biodiversity (all life forms, plants, and animals) under their jurisdiction in the form of Peoples Biodiversity Register (PBR). The PBRs have already been prepared for all the Village Panchayats, however being a dynamic document, it is updated periodically. Other responsibilities of BMCs are:

1. Conservation and sustainable utilization of biological resources.
2. Eco-restoration of local biodiversity.
3. Documentation & protection of traditional knowledge.
4. Management of biodiversity heritage sites.
5. Conservation of traditional varieties/breeds of important plants & animals.
6. Biodiversity education & awareness creation.

As per the Operational Guidelines issued by National Biodiversity Authority, a BMC shall hold minimum four meetings in a year and meet at least once in 3 months. Hence, it is advised to all the officers/officials nominated for the **"Fourth Phase of Back to Village Programme (B2V4)"** to attend the meeting of Biodiversity Management Committees of the villages allotted to them and deliberate on issues pertaining to conservation of biodiversity and sustainable utilization of biological resources, besides creation of awareness on biodiversity. The meeting of BMC will be facilitated by Panchayat Secretary/VLW.

The agenda points that may be taken up during the meeting of the BMC are given as under:-

1. Creation of awareness on Biological Diversity Act, 2002 and functions of the BMC including their responsibility on documentation of biodiversity.
2. Listing of Vaid, Hakims and traditional health care practitioners in the village.
3. Listing of individuals possessing traditional knowledge in the village.

The Unified Integrated Accessible, Transparent portal (**e-UNNAT**) with **URL <http://eunnat.jk.gov.in>**, developed, deployed and hosted in J&K State Data centre by Information Technology department , on-boarded with 107 online services fully integrated with **Meri Pechaan (National Single Sign On)** also provides a glimpse into the My Scheme portal of the Government of India by providing access to information on the schemes by re-directing through a single URL.

On MyScheme portal, UT of Jammu & Kashmir has on-boarded 10 Schemes of 6 Departments/Organisations. More Schemes will be on-boarded in due course of time. It is envisaged that in the upcoming phases, myScheme shall have the feature to apply for schemes from within the MyScheme Portal.
