

Subject: Follow up report for 4th Phase of “Back to village (B2V4) Programme”.

In compliance to the Govt Order No. 250-GAD of 2023 Dated 20-02-2023, I Kaiser Ahmad Beigh (AE R&B Sumbal) Deputed as Prabhari Officer of Halqa Panchayat Shahgund B along with Liaison Officer/PAA visited the concerned Panchayat Halqa on 23-02-2023 and interacted with the panchayat body comprising of ward members and some locals in connection to the saturation of self employment particularly and also took stock of various developmental works from the members and locals. Most of them were satisfied with the developmental works being carried out by R&B Sumbal especially under NABARD scheme. They apprised me about the JJM Scheme (RSF) whose work is under progress and pressed hard on its completion as the entire area is facing acute shortage of Drinking water as the water which is being used is not treated till date. The inhabitants are forced to use contaminated potable water which may lead to water borne diseases. To prevent any such eventuality it is of utmost priority to provide clean drinking water to the inhabitants of the Panchayat Halqa as soon as possible besides working of developmental front which should go in tandem.

Regarding the self employment generation an impetus is required to be given to one of the groups of girls who had locally made **Sanitary pads** which was unique of its kind in the entire Panchayat Halqa and most probably in the district itself. They should be encouraged and supported financially to facilitate them to make such local sanitary pads which will as good as the branded ones available in the market. It can also provide self-sustained job avenues to the major chunk as they can make money out of it. I had also earlier highlighted the same in my previous B2V4 visit held on 02-11-2022 and 03-11-2022.

Concluding it must be emphasised that lots of work is to be done on the ground which needs a systematic, comprehensive approach from administrative as well as executing bodies.
