### **ANNEXURE-A**

During the visit of Back to Village programme of Phase-V (B2V5) on 14<sup>th</sup> and 15<sup>th</sup> November, 2023 in the panchayat Porakotla of CD Block Pouni, District Reasi, number of demands/ genuine grievances have been received from the locals and PRIs of panchayat halqa porakotla, which are summarised hereunder for favour of consideration and necessary action by the District Administration Reasi/concerned Head of the Departments (HoDs) so that their demands/ grievances may be addressed for immediate relief to them.

### 1. CRF Road from Kanda to Ransoo.

The foremost complaint of residents which was also felt by the visiting Officer is the widening of the road from Kanda to Ransoo which was started in the year 2019 by the PWD(R&B) for a stretch of around 10 Kms is still incomplete and going on. The condition of the road is very dilapidated and local and others are facing lot of hardships and problems on daily basis. Ransoo is the base camp of Shiv Khori Shrine Board and around 10 to 15 thousands yatries/pilgrims visit every day from all over the India for the Darshanas of Bhole Baba. It was the strong demand of all PRIs, locals, Shopkeepers and officials who are posted in this area to complete the road in all respects by the department at the earliest.

(Action by: District Administration Reasi/Chief Engineer, PWD(R&B) Jammu)

#### 2. Ambulance 108 for PHC Ransoo.

It was informed that PHC is without 108 ambulance for long time as the earlier one met with accident and got total damage. Ransoo is a Pilgrimage station and everyday thousands of pilgrims visited Shiv Khori for Darshanas. Further, huge population is also depended on this PHC for health care services and in case of any emergency with locals/pilgrims ambulance is not available, so 108 ambulance required for 24x7 to meet any emergency. It was requested by all PRIs and local to provide one 108 ambulance immediate to PHC Ransoo.

### 3. Posting of MBBS doctors and establishment of clinical lab in PHC Ransoo.

It was informed that 02 posts of MBBS doctors are lying vacant in PHC Ransoo and only 01 Medical Officer of ISM is running the PHC. Further, there is no facility of clinical lab to the patients. It was requested alteast 01 MBBS doctor be posted in this PHC and clinical lab facility be made available to patients.

# 4. New building, posting of staff and water connection to Govt. Hr Sec School Ransoo.

The upgraded Govt., Hr Sec School Ransoo is functioning in existed building with limited accommodation of having 06 rooms only. The school needs atleast 10 more rooms for classes, Labs and Library for its smooth functioning. During examination days, school faces problems in conduct of exams and running of classes. Further, against the sanctioned strength of 39 staff, only 16 are filled. It was demanded by all PRIs and locals to construct more rooms and posting of adequate staff in Govt., Hr Sec School Ransoo so that students may not suffer any more in future. Further, there is no water connection to the Hr Sec School and students are drinking water from local Bowli. PHE department should immediately provide a water connection to the school.

### 5. Up-gradation of Primary School Ikhani.

Primary school Ikhani is almost 10 to 12 kms away from Govt., High School Kotla. There is no transportation facility in the area. There are two more primary schools P S Kantha Gool, PS Chinar also running in the area. There is need of middle school as children have to walk long for high school Kotla. It was the demand of PRIs and residents of Ikhani Gool area to up-grade the primary school Ikhani to middle school so that children may be deprived from their education in these remote areas.

### 6. Maintenance of Irrigation Khul Ransoo.

The irrigation Khul Ransoo which was constructed in 1984 and thereafter no major maintenance was done by the department as informed during Gram Sabha and it has been damaged at different location and needed immediate repair so that farming community get water for agriculture purpose at right time.

### 7. Special Aadhaar Camp at Ransoo

It was apprised that some of residents are still left not covered under the Aadhaar cards in the remote mohras of the panchayat viz Ikhani, Gool, Chinar Sangar etc and updation of Aadhaar card is also required for linking of PM KISAN, PMABY, generation of ABHA number, KCC, opening of bank accounts, linking of Aadhar number with Govt., scheme also. It was requested to have a Adhaar Camp for atleast 10 days at base camp Ransoo so that left out residents of remote/ adjoining areas especially the sick and senior citizens may be covered in the camp.

### 8. Resumption of SRTC Bus service from Kotla to Jammu.

SRTC was plying a bus service from Kotla to Jammu has now been stopped without unknown reasons due to which residents are facing problems especially school and college going children. It was the demand that the STRC bus service again be resumed at the earliest.

### 9. Lighting and washroom/facility at Bus Stand/Taxi stand Ransoo.

It was informed that the existing lights are not functioning and needs Solar lights at Bus Stand Ransoo so that the pilgrims who came for the darshanas may be face any further inconvenience. Besides, the toilet constructed at Bus stand/ Taxi stand Ransoo are not functioning. The pilgrims who reached Ransoo after travelling hours have no facility of washroom. The demand of PRIs and local is to resolve the issue on priority so that pilgrims may not suffer due to basic needs/ facilities.

### 10. Drinking water issues in Ikhani Gool area.

PHE Department is not executing any work under Jal Jeevan Mission (JJM) in the area of Ikhani Gool and peoples are still facing drinking water problems. If PHE department construct a tubewell and tap the local sources of water, the problem of drinking water can be solved to some extent.

11. Training of local women under SHG.

It was the demand of PRIs and local women that Skill Dev Department shall trained the local women in making bags or other items for packing of Parshad for the Shiv Khori Pilgrims so that the women folk may get some sustenance activities of livelihood.

12. Foot bridge on Ikhani Gool Nallah.

The locals appraised that the school going children facing problems during the raining days in crossing the nallah and demanded for construction of a foot bridge on Ikhani Gool Nallah.

13. Passenger shed at Ikhani Galla.

A demand was raised by the local people during the meeting that a passenger shed is required at Ikhani Galla for Bakerbals, Gujjar and other tribal people who used this track to go upper reaches along with their livestock, sheep and goats.

14. Construction of khuls at Pora.

A demand was also raised by the local farmers and PRIs with regard to construction of pacci khuls by the CAD Department as there is around 400 to 500 Kanals of fertile agriculture land in the vicinity of Ransoo town in which mainly paddy and wheat is cultivated and the Pacci khuls is the need so that water may reached to the tail end of their fields.

15. Construction of roads.

There was the demand of PRIs and locals people of panchayat halqa Pora Kotla to construct the following roads viz,

- Tractor road from Taxi stand to Lagga Dab approximate 500 mtrs.
- ii) Link road from PMGSY road to Bipan Kumar house,
- iii) Road from Pukhrani to Sugga Khetar approx 750 mtrs,
- iv) Tractor road in W.No 9 from Sugad to Naggakot glok almost 1 kms,
- v) Const of road from Berrigalla to Sunarian in W.No 4 under PMGSY,
- vi) Construction of lane and drain at Seri Chapadi to the house of Raj Kumar shop in W.No 3.
