	1	Marheen Panchayat has a rich agricultural land and corps like Rice, Wheat, Vegetables, Sugarcane etc. It is located around 10 Km from the National Highway at Chadwal. The access road is macadamized and all type of transport facility is available. The young generation is hardworking and possess a great sense of sporting sentiments irrespective of the fact that there is no such playground available. There is 100% enrolment and the schools of different standards including high and higher secondary school are performing very well. The teaching faculty is punctual and committed towards the better future of the students. The following suggestions are suggested to be considered while framing future plans. i. The housing infrastructure of Middle School Nova Chak and Girls High School Marheen need immediate attention as some portion of the buildings of the said schools does not seem to be safe for housing students. Therefore, the said dilapidated portion of the buildings of the said schools be immediately reconstructed/renovated. Otherwise also the class room facility available is not sufficient to cater the enrolment as per the standards of the department. To this effect Tehsildar Marheen was directed to get the safety audit of the said schools conducted for further necessary action i.e. re-errection of the said portion of the school buildings.
	2	Health facility being one of the prime importance also require attention, as the only PHC building in Panchayat Marheen is also in dilapidated condition, even trees have grown up on terrace of the building and roots have got penetrated inside the rooms where bedding facility for the patients is available. Overall improvement of the PHC

	in terms of equipments, reagents and other basic necessities is also required to be upgraded which includes sonography/ultrasound, ECG and X-Ray etc. This also assumes significance in view of the fact that it is the only health facility catering the Border Forces as well as the residents of Marheen and adjoining villages.
3	The demand of the people since B2V1 regarding availability of a playground and a library is of prime importance need to be addressed on priority.
4	It shall be of great benefit to the BPL people in getting the benefits of various centrally sponsored/UT schemes, if the ration cards of the BPL families post 2011 Census shall be considered for issuance to such eligible families.

The teaching faculty is punctual and committed towards the better future of the students. The following suggestions are suggested to be considered while framing future plans. ii. The housing infrastructure of Middle School Nova Chak and Girls High School Marheen need immediate attention as some portion of the buildings of the said schools does not seem to be safe for housing students. Therefore, the said dilapidated portion of the buildings of the said schools be immediately reconstructed/renovated. Otherwise also the class room facility available is not sufficient to cater the enrolment as per the standards of the department. iii. Health facility being one of the prime importance also required attention as the only PHC building in Panchayat Marheen is also in dilapidated condition, even trees have grown up on terrace of the building and roots have got penetrated inside the rooms where bedding facility for the patients is available. Overall improvement of the PHC in terms of equipments, reagents and other basic necessities is also required to be upgraded. This assumes significance also being the only health facility catering the Border Forces as well as the residents of Marheen and adjoining villages. iv. The demand of the people since B2V1 regarding
		availability of a playground and a library is of prime importance need to be addressed on priority.
		v. It shall be of great benefit to the BPL people in getting the benefits of various schemes if the ration cards of the BPL
		families post 2011 Census are being issued.
