The following monthly fee structure to collect user fee for Management of waste Generator to be implemented in the Halga pvt

[1] Households

- (a) INR 100 per month.
- (2) Shops & Commercial establishments.
- (a) up to 500 Sq. ft - INR 100 per month.
- (b) > 500 Sq. ft for more - 100 per 200 per month.

[2] Restaurants, Eateries and Meal Shop

- (a) upto 500² ft - INR 200 per month
- (b) > 500 sq. ft or more - INR 400 per month

(3) Shops & Commercial Establishment

- (a) Up to 500 sq ft - INR 100 per Month
- (b) > 500 sq ft or more - INR 200 per Month

(4) Hotel & Lodging

- (a) INR 500 per Month + additional fee

(5) Govt. Private offices, Banks, police station & office establishment

- (a) INR 200 per Month

(6) Hospitals & Health Care Centres

INR 500 per Month

(7) Educational Institutions

INR 200 per Month

(8) Residential Institutions (Schools, Colleges etc)

- (a) INR 500 per Month

(9) Industries for Non-hazardous (waste) Including Cold Storage, godowns etc

- (a) INR 500 per Month = Small Industries
- (b) INR 1000 per Month = Medium Industries
- (c) INR 2000 per Month = Large Industries
- (d) INR 200 per Month = Micro Industries

(10) Marriages Halls, Bus Stand & other places Exhibitions

- (a) 1000 per Month
