The following monthly fee structure to levy and collect user fee for management of Solid waste management from various waste generators shall be implemented across the whole Panchayat user charges for the solid waste management from various waste generators (Per month)

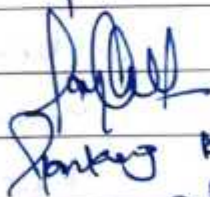

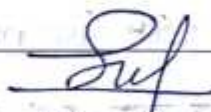

Another agenda point regarding requirement of State land for waste segregation was also discussed in the meeting.

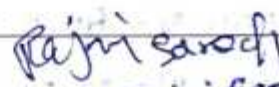

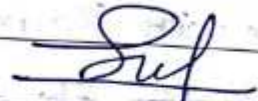
RUDA Agency

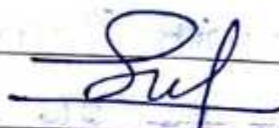
Comprehensive list of household

The fifth agenda point which was discussed in the meeting was list of household who were agreed to give charge to the agency which will collect waste from their door step.

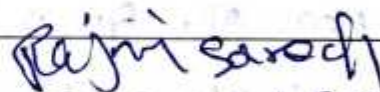
