INR 100 per month

Upto 500 Sq.ft INR 100 per month

Upto 500 Sq.ft or more INR 200 per month

c) Residential, cateries, Meat shop

Upto 500 Sq.ft INR 200 per month

Upto 500 Sq.ft or more 400 per month.

d) Hotel

INR 500 per month + additional fee on extra

e) Government-Private Offices, brick, Palace, station establishment.

INR 200 per month

f) Hospital and health care center

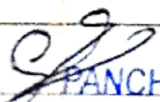
After long discussions as per directions received from higher authorities Committee was formed. The members of Committee are as follows:-

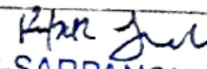

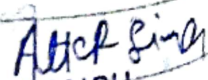
Ruda Agency
