Panchayat - Badyal Brahmana Lower

Today as on 1/10/2022 a special meeting of PRI's members of Panchayat Badyal Brahmana Lower Block R.S.Puram was held under the chairmanship of Sarpanch Smt. Kanta Sharma. The Agenda of meeting was regarding passing of specific by-laws in context of management of solid waste generated in the panchayat & their subsequent adoption. In addition to adoption of by-laws regarding solid waste management the PRI members also agreed for constitution of Halga level Sanitation Committee.

The following monthly fee structure has been proposed in context of Laying & collection as user fee for Management of SWM, from various waste generators across the Halga Panchayat.

1.) Households:-

(a) Rs 100/- Month

2.) SHOPS AND COMMERCIAL ESTABLISHMENTS:-

- (a) up to 500 square ft. - Rs 200/Month (Hundred Rupees only)
(b) > 500 sq. ft - Rs 200 /month (Two Hundred Rupees only)

3.) HOSTELS & LODGINGS.

- (a) Rs 500/Month + additional fees on restaurant & eatery in their premises.

9.) RESTAURANTS, EATERIES AND MEAT SHOPS:

upto 500 sq. ft - Rs 200/month
> 500 sq. ft - Rs 400/month

5.) Govt/private offices, Banks, Police station & other establishments.

a) Rs 200/month

6.) Hospitals & Health Care Institutions.

a) Rs 500/Month

7.) Educational Institutions

a) Rs 200/month

9.) Industrial [for Non-Hazardous Waste] including Cold storage, godowns etc.

a) Micro Industries - Rs 200/Month

b) Small Industries - Rs 500/Month

c) Medium Industries - Rs 1000/Month

d) Large Industries - Rs 2000/Month

10.) Marriage Halls, Hoats, exhibition, bus stands Place of Community Assembly.

a) Rs 1000 / Event.

PROPOSED PENALTY PROVISION

A Meeting of the Halga Panchayat Committee on solid Waste Management shall be convened every month to decide & Levy a one time fine on the offenders for littering or burning of Waste.

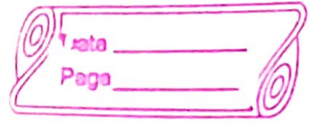

Another Agenda point regarding requirement of State land for waste Segregation was also discussed in the meeting.

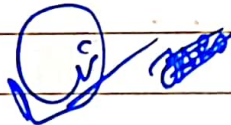
